MEETING CALL TO ORDER

New Business:

1. Recap of the Previous Meetings Discussion
 - a. The board discussed the minutes from the previous meeting.
2. Review of the Fire Department MRI Study from 2015/16
 - a. Jeff Leblanc reported on the MRI study and presented his findings. See the attached document for further information. The board discussed the completed tasks first, and then continued by explaining some of the issues that the department is facing.
3. Discuss Potential Issues the Deering Fire Department are Facing
 - a. After review of the Not Completed section, the board discussed a priority of the list. The topics that they prioritized were:
 - i. Reduction of Response Time,
 - ii. Lack of Exhaust Systems,
 - iii. Training of Staff to FF1,
 - iv. Fire Detection,
 - v. Radios for FD Members,
 - vi. Combined Structure,
 - b. The committee agreed that this number of tasks would take a wide variety of potential solutions to address. In doing so they split up researching to the members individually.
 - i. J. Peel and J. Leblanc would reach out to regional towns about potential EMS agreements, research full-time staffing costs, continued staffing effects, contracted EMS Fees.
 - ii. P. Murdough would research the cost of exhaust systems for the stations and what it would cost in a singular structure
 - iii. S. Diers will research fire detection devices and review the radio quote that the FD used to apply for the state grant.
 - iv. K. Parese would review the structure of the combined Station by reviewing regional stations and compare them to Deering's needs.
4. Other Business as Defined by the Committee
 - a. The committee agreed that the next meeting would be held at Donovan Station.
