> Meeting Minutes July 16, 2020

Selectmen present: Allen Belouin, Rebecca Mitchell, Bill Whisman

The meeting was called to order at 1900 via video teleconferencing because of the COVID-19 public health crisis and Governor Sununu's emergency order #12 pursuant to Executive order 2020-04 which authorizes the Board of Selectmen to meet electronically.

Mr. Whisman made the motion to approve the consent agenda. Ms. Mitchell seconded the motion. The vote was unanimous and so moved.

NEW BUSINESS:

Town Clerk – Part-time Assistant Clerk Proposal

Deering Town Clerk, Carol Baker, briefed the Board on a proposal to add an assistant clerk position to the office. Ms. Baker explained that the current Deputy Town Clerk is retiring at the end of the year. Hiring an Assistant Clerk now is a way to provide an overlap during the transition. Another purpose it serves relates to the number of municipal agent seats available to the office. The office currently has two licenses to access the State's DMV registration software. If the position of Deputy Clerk becomes vacant through retirement without any replacement the Town will lose a municipal agent seat. Processing registrations without a second means of access results in long lines of people waiting to complete their registrations. The cost of the position is approximately \$5,000 @ \$15 per hour and 15 hours per week and there is room enough in the Clerk's budget. The position is temporary. Discussion ensued among Board members. Mr. Whisman made the motion to approve the temporary position of Assistant Town Clerk to cover the transition period with the position working 15 hours per week at a rate of pay of \$15 per hour. Ms. Mitchell seconded the motion. The vote was unanimous and so moved.

BOS Meeting Minutes

Police Chief – New Hire Request

The TA explained that the Fire Chief was originally slated to attend the meeting but was unable to attend so the TA scheduled the request by Chief Philibert to hire a part-time office. The department has been down several part-time officers for many months. The TA referred to the agenda packets that contained the resume and completed background for the applicant. The TA noted that Robert McAllister came well recommended with over 30 years as a full-time officer. Newly retired, Mr. McAllister is looking to stay active in law enforcement and Deering represented an excellent opportunity to do so. Mr. McAllister is full-time certified so there will be no additional certification costs. Mr. Whisman made the motion to approve the hiring of Robert McAllister as a part-time police officer with an hourly rate of pay, as recommended by Chief Philibert, of \$23.33 an hour. Mr. Belouin seconded the motion. The vote was unanimous and so moved.

Leasing for new Fire Truck - \$200,000 / Ten Year Term / 2.74% APR

The Board reviewed language changes in the lease documents recommended by legal with the TA commenting that Primex, the Town's insurer, had yet to provide comments on the lease language. The language changes will be complete for the next meeting.

COVID-19 updates

A discussion about the surge in new cases seen in many States. The is a general concern among Board members that the increases may be in easy traveling distance to Deering which has between 1 and 4 positive cases so far.

Non Public Session – RSA 91-A:3 II(a)

Mr. Whisman made the motion to enter non-public session under RSA 91-A:3, II(a) to review the Departments Performance Reviews. Mr. Belouin seconded the motion. The vote was unanimous and so moved. Roll call vote: Allen Belouin, Aye; Rebecca Mitchell, Aye; Bill Whisman, Aye.

The Board entered non-public session at 1925.

The Board re-convened in public session at 1948.

There being no further business to come before the Board Mr. Whisman made the motion to adjourn. Ms. Mitchell seconded the motion. The vote was unanimous and so moved. The meeting adjourned at 1953.


Primary Roads / 1 Surveys

June 2020 Highway Dept. Report

June brought us three weeks of very dry weather. Brett has been very busy grading all our gravel roads. We have put calcium down on North, Clement Hill gravel portion, Dickey Hill gravel portion, Bowen School, both sides of Tubbs Hill, both sides of Wolf Hill, gravel portion of Fisher, Gove, Camp, Bartlett Hill, Pleasant Pond, top of the Glen, Longwoods, County Ext, Blueberry Hill, Donovan, Skye Farm, The Turnpike, Farrell Hill and the steep hill on Zoski. We have Driscoll, the bottom of the Glen, Hart farm, Mountain View, Pond and Hedgehog Mtn left to do.

The beavers were very active at the beginning of the month on Gerini Brook and County Road. We cleaned the loam off the top of the area at our pit where the winter sand will be taken out of this year. We loamed around the outside of the Town Common where winter plowing had taken it back over the years and loamed up to the granite blocks on the 149 side of the Town Hall parking lot. We had them hydroseeded and we watered it every day during the dry spell. The outside area of our shop has been getting work done as time permits. Darin installed the trim boards on our "new" shed, we moved the culverts off the septic system and made a new place for them. We measured out where the septic is and our tank and started to clean off the scrub brush that has grown up on it.

Things coming up for us are loaming the top of our septic system, getting quotes on equipment to rent for screening our winter sand, putting out to bid road work for Longwoods Road and Hoeton Crossing and roadside mowing for all our roads. Things for our shop will be repairs to the siding on the back side of the shop between grading and ditching.

We are all healthy here at the Highway Department and pushing forward though Covid 19.
