TOWN OF DEERING JUNKYARD LICENSE APPLICATION INFORMATION

LICENSE APPLICATION:

Whether you are applying for a junkyard license for the first time or for a renewal of an existing license consult with the Town Code Enforcement Officer, who can answer any questions you may have as to whether the junkyard business meets the qualifications described in the Deering Zoning Ordinance Section 4. You may be required to apply first to the Zoning Board of Adjustment for a Special Exception or a Variance or apply for a Site Plan Review with the Planning Board.

Applications that are incomplete when submitted to the Town will not be protected from any of the following changes:

- Code update adoptions
- Department policy changes

New application forms for a junkyard license are required each year and will not be reviewed until all required and pertinent documents have been submitted to the Code Enforcement Officer for that license period.

FEE PAYMENTS:

Pursuant to RSA 236:121, junkyard licenses expire on June 30th of each year. Junkyard licenses may be renewed thereafter upon payment of an annual license fee to the Town of Deering in the amount of two hundred fifty dollars (\$250.00) pursuant to RSA 236:122.

Junkyard licenses will be renewed without a hearing if all provisions of Section 4 of the Town's ordinance and RSA 236:111, et seq. have been complied with during the license period.

At the discretion of the Board of Selectmen, appropriate investigations of each licensee may be conducted prior to the issuance of a renewed junkyard license including, but not limited to, the testing of surface and subsurface water for contamination by hazardous or toxic substances.

The Town is authorized to enter upon the junkyard site with proper notification for the purpose of obtaining surface and subsurface groundwater samples and inspecting the premises for compliance with the other requirements of Section 4 of the Deering Zoning Ordinance.

To the extent that any provision under this section conflicts with any provision of any other applicable law, ordinance or regulation, the provision which imposes the greater restriction or the higher standard shall be controlling.

All permits granted hereunder are personal to the applicant and cannot be re-assigned.

Notice of Approval will be granted when the Applicant/Owner has received a copy of the approved application form signed by the Board of Selectmen.
