MONTHLY REPORT APRIL 2012

NEWS:

- 1. Applications are still available at the PD or on the NH Chief's of Police Association website for the 31st Annual "Police Cadet Training Academy" to be held at the NHTI Campus in Concord from June 23-June 30, 2012. This is a weeklong "academy" camp for teens interested in Law Enforcement. The Deering PD's "Hillcat Post #612 Police Explorers" hope to send a couple Cadets to this. I believe we have 5 Cadets who will be attending this year!
- Chief Pushee took a four person team of Cadets to the 2012 Police Cadet Challenge Weekend from April 27-29th. The team garnered a 5th place finish in the Drill and Ceremony portion of the competition, and a 6th place in the Building Search portion. Chief Pushee and Volunteer/Cadet Advisor Jim Hargreaves sponsored and ran the Building Search Scenario at this event.
- Chief Pushee and Capt. Cavanaugh attended the wake, while Chief Pushee and Ofc. Migdal attended the Funeral Procession, for Greenland PD Chief Mike Maloney, who was killed in the line of duty on April 12, 2012.

TRAINING:

- 1. Most PD Officers went through their required annual handgun qualifications, though a couple officers schedules changed last minute, so they could not attend, and we will try to catch up in May. All officers still required to complete Rifle & Shotgun qualifications. Qualifications are not "training" so we still have some work to do with everyone.
- One of our two schedules training dates was canceled so Officer(s) could attent the Funeral Services for Greenland Police Chief Mike Maloney.

GRANTS:

- 1. Highway Safety Agency Grants: OPERATION SAFE COMMUTE: This grant program continues, and assigns for one day each month an extra cruiser on the road for safe driver & enforcement patrols during specific "commuter" hours.

1. We had no Diversionable Juvenile Cases in April 2012.


