

MONTHLY REPORT**April 2011****NEWS:**

1. Ofc. Migdal graduated the 154th NH Police Academy on April 8th. He entered the FTO Program, and will be easing into solo patrols near mid/late May 2010.
2. Chief Pushee is continuing the process of reviewing/modifying the Police Policy Manual as time allows.
3. Officer Lisa Censabella tendered her resignation as a Part-Time Officer, citing schedule conflicts with her full time employment and her growing familial obligations.
4. There was an Arson based fire/explosion in West Deering, and ensuing suicide, that we continue to investigate aspects of. The Fire Department, NH Fire Marshals, and Hillsboro and Francestown Police Departments assisted with initial response, scene security, and the Arson investigation.
5. Members of Cadet Post #612 attended Annual Cadet Challenge Weekend, garnering 5th Place in Drill & Ceremony and 5th Place in Cruiser Push competitions.

3. Capt. Cavanaugh attended a training session at PSTC on DWI Case Preparation and Courtroom Testimony.

3. Highway Safety Agency Grants: Statewide DWI Hunter Weekends: this application for overtime dedicated DWI based enforcement efforts on 3 weekends this summer has received final approvals.
4. OHRV Enforcement Grant: We will begin these patrols this month, focusing on education and enforcement of OHRV Laws and closed trail/land enforcement.

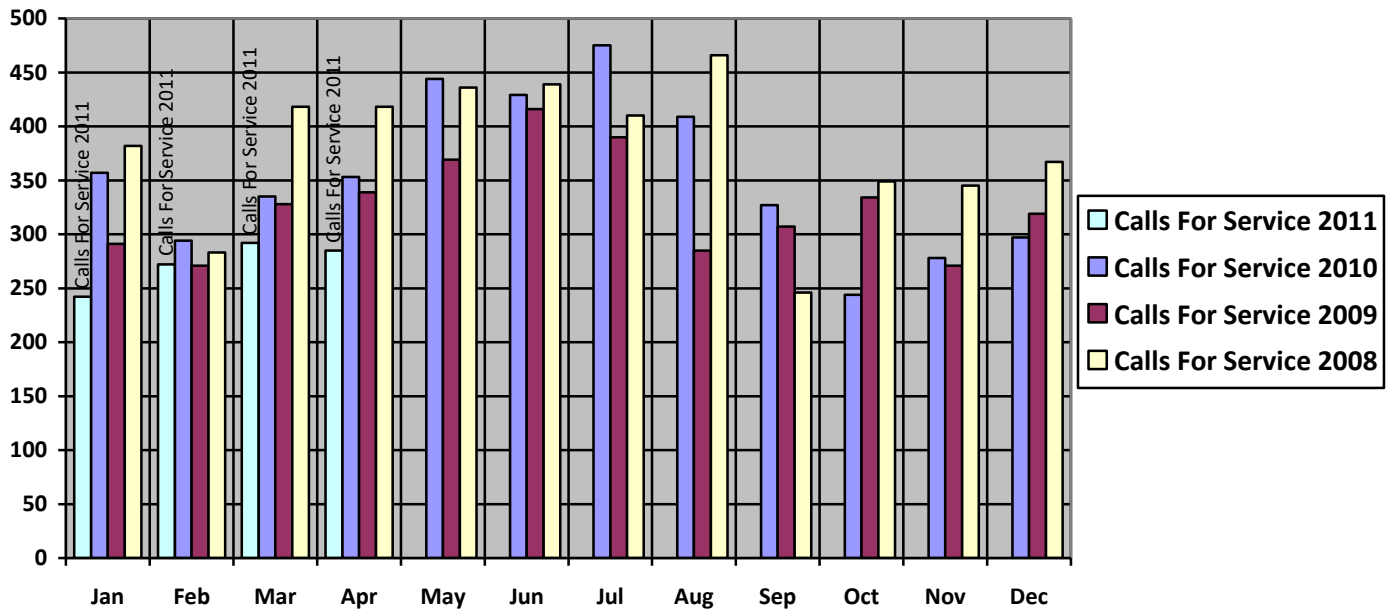
