

MONTHLY REPORT**August 2012****NEWS:**

1. Chief Pushee took his annual 2 week family vacation this month.
2. Police Cadets were busy this month, with Community Service Details, including Annual Mountain Bike Race, Washington's 225th Anniversary Celebration, Funeral/Wake Detail, End of Summer Trip to Canobie Lake, etc. We also have had several new members joining recently.
3. Cadet Lindsay D. has "aged out" of the Cadet Post. She is the only one of our original members to stay in the program until she no longer could, BUT she has agreed to stay on with us as a Civilian/ Assistant Advisor to the Cadets, AND she is currently Interning with us for her NHTI Course Requirements.

TRAINING:

1. Capt. Cavanaugh canceled planned Dept. Training in August due to several conflicting issues.
2. Ofc. Migdal attended a 3 day Interview and Interrogation Class, sponsored and paid through grant programs with the New England Counterdrug Task Force, the National Guard, and hosted by the NH Liquor Enforcement Agency.

GRANTS:

1. Highway Safety Agency Grants: OPERATION SAFE COMMUTE: This grant concludes on Sept. 4th, and then we will put in for reimbursement. Chief Pushee has already been notified that Deering PD will be included in the Safe Commute Grant Program planned for October 2012 thru Sept 2013 as well.
2. 1033 Defense Reutilization Program: nothing recently on this grant, though the program is undergoing "login/sign-in" changes that are requiring some new forms and online passwords, which Chief will get to once he catches up from work accumulated during vacation.
3. Highway Safety Agency "Speed" Grant 2012: This grant program was completed in August, and Chief Pushee will be preparing reimbursement requests.
4. Highway Safety Agency "Local DWI" Grant 2012: This grant program will conclude on Sept. 15th, and Chief Pushee will then begin preparing final reports and reimbursement requests.

JUVENILE ACTIVITY:

1. We did end up sending 4 Juveniles to the Merrimack County Youth Diversion program from the previously noted July 2012 incident.
2. No other August 2012 diversionable cases, though on Sept. 1st Capt. Cavanaugh broke up an underage drinking party which may result in some underage parties going through certain alcohol diversion programs.

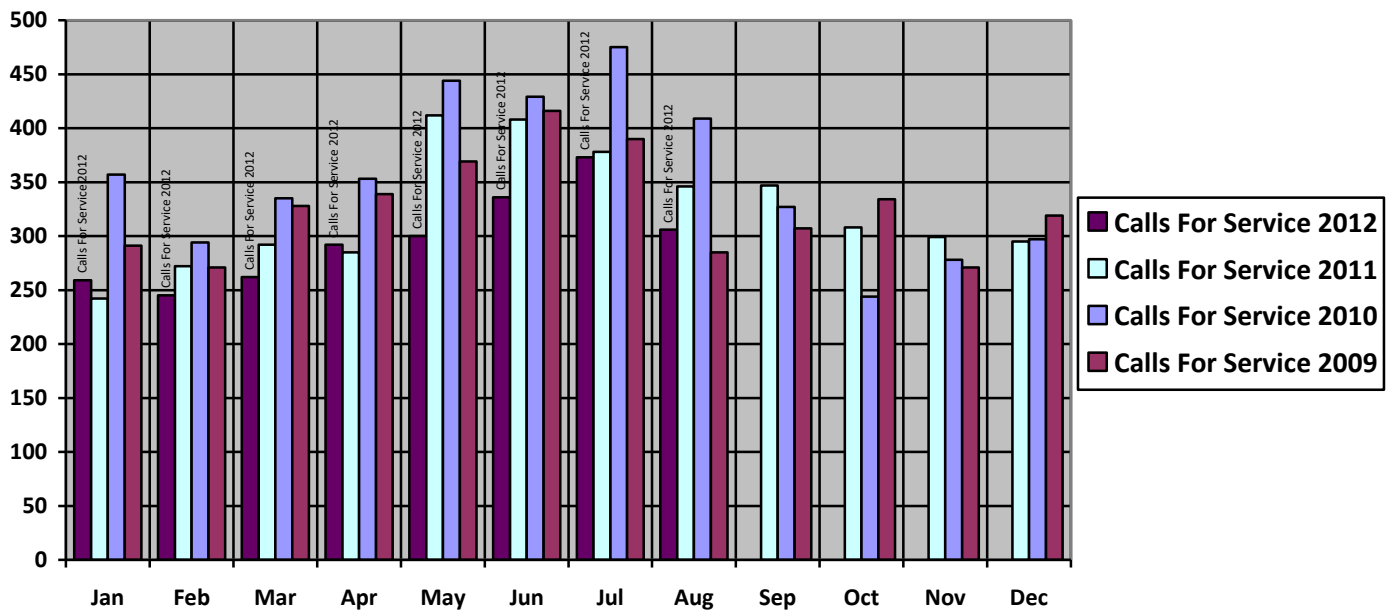
