

MONTHLY REPORT**December 2011****NEWS:**

1. Nick Hodgen has rejoined the department as a Part-Time Police Corporal.
2. After various discussions with Town Administrator, Chief Pushee has "jumped ship" from the IMC Police Computer Records System, and we will be working towards activating "Crimestar" for these purposes. This will provide significantly more abilities at a lower annual cost factor, such as multi-user accessibility, photo modules, administrative modules, training history modules, vehicle/property/evidence inventory modules (including the ability to utilize bar code scanning for evidence control), etc.

TRAINING:

1. Chief Pushee recertified as Breath Test Operator.
2. Chief Pushee received training brief on Outlaw Motorcycle Gangs in NH during monthly Chief's Meeting.
3. January training is scheduled to include training on the new computer system as well as training in the Pepperball Less-Lethal Defense Tools.

GRANTS:

1. Highway Safety Agency Grants: OPERATION SAFE COMMUTE: This grant program continues, and assigns for one day each month an extra cruiser on the road for safe driver & enforcement patrols during specific "commuter" hours.
2. 1033 Defense Reutilization Program: Chief Pushee continues to scan for useful surplus equipment that would be nearby and readily accessible to obtain with limited outlay.
3. Highway Safety Agency "Speed" Grant 2012: This has been submitted electronically.
4. Highway Safety Agency "Local DWI" Grant 2012: This has been submitted electronically.
5. Highway Safety Agency "Computer System Upgrade" Grant: I have submitted a grant application with hopes that NH Highway Safety will provide up to 50% of the buy-in for the Crimestar Police Computer Records System. Highway Safety usually does not grant such funds to "replace" an existing records system, but I am hoping that with the significant upgrade to our system accessibility and options, they will see this as a worthy project to fund.

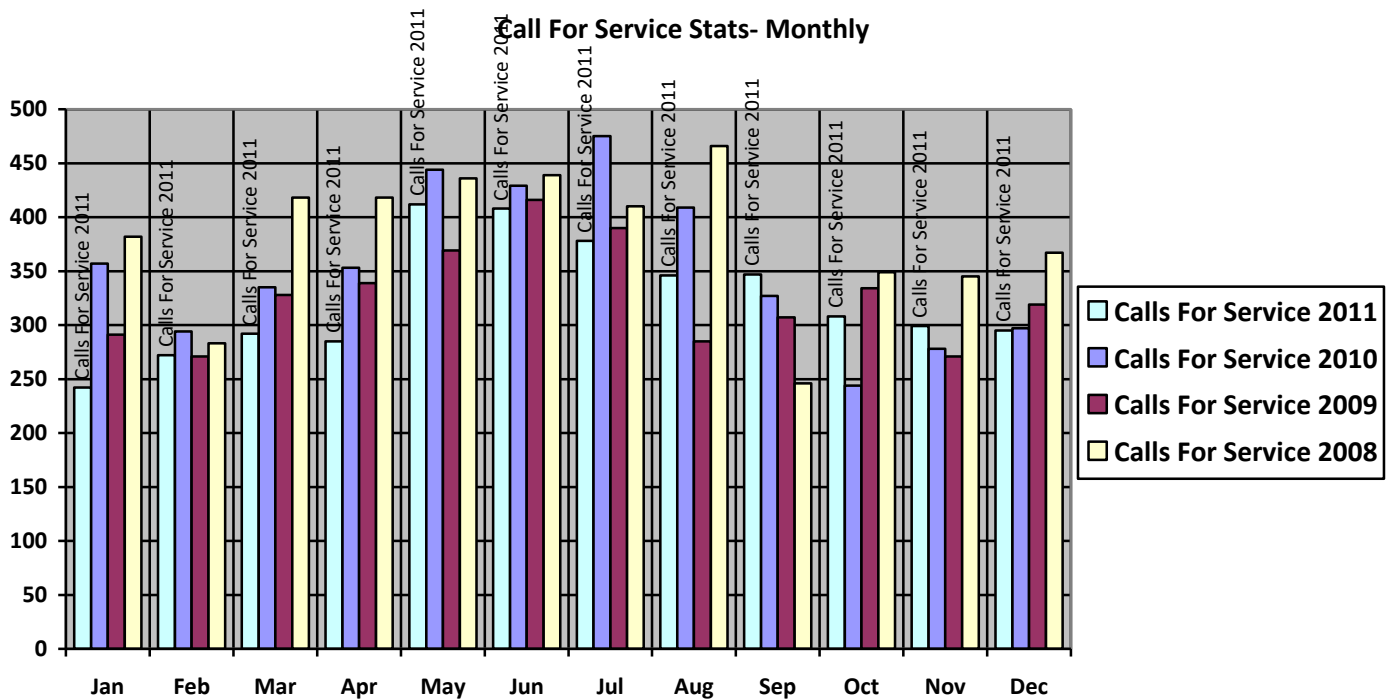
