

**MONTHLY REPORT****FEBRUARY 2012****NEWS:**

1. Applications are available at the PD or on the NH Chief's of Police Association website for the 31<sup>st</sup> Annual "Police Cadet Training Academy" to be held at the NHTI Campus in Concord from June 23-June 30, 2012. This is a weeklong "academy" camp for teens interested in Law Enforcement. The Deering PD's "Hillcat Post #612 Police Explorers" hope to send a couple Cadets to this.

**TRAINING:**

1. Capt. Cavanaugh and Ofc. Migdal went to a training class on dealing with mentally ill subjects.
2. Chief Pushee and Ofc. Migdal went to a training class on Suicide Prevention/Postvention.
3. PD conducted "Part A" of our required Annual Use-of-Force Classroom (use-of-force and pursuit policies, statutes, etc.)
4. Chief Pushee and Ofc. Collins attended a training session on "Suspicious Activities Reportings" (homeland security initiatives).

**GRANTS:**

1. Highway Safety Agency Grants: OPERATION SAFE COMMUTE: This grant program continues, and assigns for one day each month an extra cruiser on the road for safe driver & enforcement patrols during specific "commuter" hours.
2. 1033 Defense Reutilization Program: Chief Pushee has applied for up to 2 "Kawasaki Mule" side-by-side off-highway vehicles. They are "reportedly" in very good condition with full cabs, and are located in August, ME. If approved they could be used by PD and FD for emergency response in remote areas, for OHRV Patrols, by Explorers during details and events, ETC. New these cost over \$10K each.
3. Highway Safety Agency "Speed" Grant 2012: This grant has been approved and we have started working these 4 hour overtime patrol grants.
4. Highway Safety Agency "Local DWI" Grant 2012: This grant has been approved and we have started working these 5 hour overtime patrol grants.
5. Highway Safety Agency "Computer System Upgrade" Grant: I have re-applied on this grant program specifically for our second user license.

1. We had no Diversionable Juvenile Cases in February 2012.

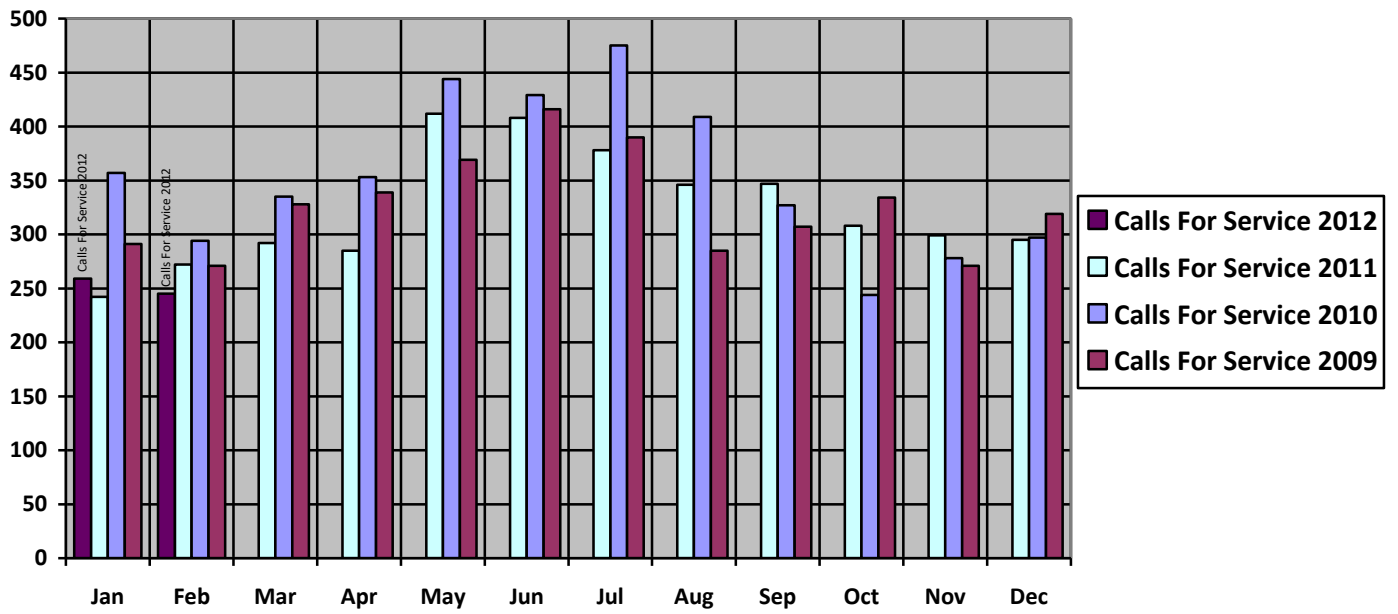
