

**MONTHLY REPORT****March 2010****NEWS:**

1. Chief Pushee and Capt. Cavanaugh completed the Background Investigation for applicant Ellen Kraus, who is now ready to be Sworn-In as Part Time Police Officer.
2. Ofc. Hargreaves is working hard with the Explorers, who provided assistance to the Town on Election Day and Town Meeting Day, as well as weekly training sessions to prepare for Annual Competition at the end of April.
3. Captain Cavanaugh is out on medical leave for a couple of weeks, but appears to be recovering well.
4. 2007 CVPI, which will be taken off-line within this month, was borderline on Inspection, but passed with frequent "tire checks" assured. Still suffering with rear main seal oil leak and worn "front end."
5. 2010 Chevy Impala, as of Monday April 1<sup>st</sup>, was believed to be enroute from factory on Rail Car, perhaps sitting on siding in Framingham, MA, waiting to be put on truck to dealer.

**TRAINING:**

1. Police Department utilized the vacant "Burn House" in West Deering for some extremely relevant firearms and use-of-force scenario training.
2. Chief Pushee attended the NH Prescription Drug Abuse Summit training seminar.

**GRANTS:**

1. Speed Enforcement Grant 2010 / Highway Safety Grant Programs: Due to scheduling, weather, and equipment (cruiser) issues, we only worked one Speed Grant shift in March, though speeds are beginning to rise at this point.
2. DWI Enforcement Grant 2010 / Highway Safety Grant Programs: We worked a couple DWI Grant Patrols in March, including one which netted 6 arrests based on a Suspicious Vehicle Check.
