

**MONTHLY REPORT****March 2012****NEWS:**

1. Applications are available at the PD or on the NH Chief's of Police Association website for the 31<sup>st</sup> Annual "Police Cadet Training Academy" to be held at the NHTI Campus in Concord from June 23-June 30, 2012. This is a weeklong "academy" camp for teens interested in Law Enforcement. The Deering PD's "Hillcat Post #612 Police Explorers" hope to send a couple Cadets to this.
2. We have a Hillsboro resident who is a student at Norwich University that is planning to work with us this summer as an Intern (non-paid).
3. 2003 Ford Expedition was down for over a week for repairs to keep it inspectable. Basically replacing "front end" and suspension parts, et al.

**TRAINING:**

1. Ofc. Philibert completed his required Use-of-Force PART A annual classroom training requirement. (use-of-force and pursuit policies, statutes, etc.)
2. PD conducted "Part B" of our required Annual Use-of-Force Classroom (handcuffing refresher, weapon retention, disarming, practical exercises)
3. Ofc. Hodgen went through an online recertification at HPD for his HPD issued taser (which he carried when working in Deering, under our policy).
4. Ofc. Collins attended a weeklong class in "Interviews and Interrogation" methods to help her with investigative interviews.

**GRANTS:**

1. Highway Safety Agency Grants: OPERATION SAFE COMMUTE: This grant program continues, and assigns for one day each month an extra cruiser on the road for safe driver & enforcement patrols during specific "commuter" hours.
2. 1033 Defense Reutilization Program: We did NOT get the Kawasaki Mules that Chief Pushee applied for. Our State Coordinator had approved us for one of them, but another military post exercised "first right of refusal" and took these vehicles.
3. Highway Safety Agency "Speed" Grant 2012: This grant has been approved and we have started working these 4 hour overtime patrol grants.
4. Highway Safety Agency "Local DWI" Grant 2012: This grant has been approved and we have started working these 5 hour overtime patrol grants.
5. Highway Safety Agency "Computer System Upgrade" Grant: We DID receive approval on this grant, which will pay \$1500 (50%) of the cost of our second user license for the new Crimestar Police Records System.

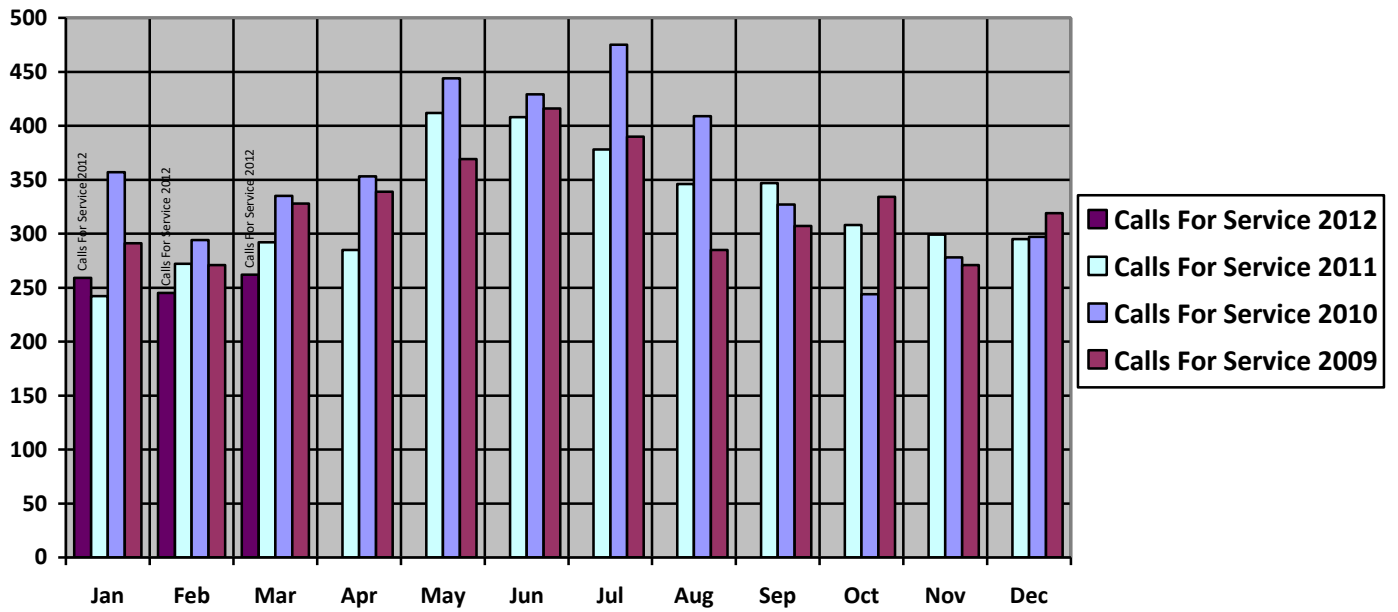
