# MONTHLY REPORT

## **MAY 2012**

#### **NEWS:**

- 1. We have 5 Cadets from Explorer Post #612 registered to attend the NH Police Cadet Training Academy during the last week of June!
- 2. Due to a crash, we are down a cruiser. This is causing significant hardship to the PD at various times.
- 3. In addition to a Sexual Assault case that occurred in Deering (see arrests below), we took an initial report and interviewed victims in another complaint, learning that this other offense actually occurred in Hillsboro. HPD is continuing this investigation.

### **TRAINING:**

- 1. One of our two schedules training dates was canceled so Officer(s) could attent the Funeral Services for Greenland Police Chief Mike Maloney.
- Annual Firearms Qualifications: The entire PD has completed handgun qualifications in April and May. Many of us completed Rifle and Shotgun qualifications during May. Still have a couple more officers on one or the other. We need to start actual firearm "training" (different than qualifications).
- 3. Annual OC Pepper Spray & Pepperball Training: The Department (all but one who couldn't make it) were certified in the use of the Pepperball Launchers, and also received their annual OC Pepper Spray recertification at the same time.
- 4. Capt. Cavanaugh was recertified as a Breath Test Operator.
- 5. Several officers have training scheduled in house, at the academy, and outside the academy during June.

#### **GRANTS**:

- 1. Highway Safety Agency Grants: OPERATION SAFE COMMUTE: This grant program continues, and assigns for one day each month an extra cruiser on the road for safe driver & enforcement patrols during specific "commuter" hours. I prepared and sent quarterly activity reports to the NH Highway Safety Agency on this grant.
- 2. 1033 Defense Reutilization Program: still looking for useful items nearby on this program.
- 3. Highway Safety Agency "Speed" Grant 2012: This grant has been approved and we have started working these 4 hour overtime patrol grants. I prepared and sent quarterly activity reports to the NH Highway Safety Agency on this grant.
- 4. Highway Safety Agency "Local DWI" Grant 2012: This grant has been approved and we have started working these 5 hour overtime patrol grants. I prepared and sent quarterly activity reports to the NH Highway Safety Agency on this grant.
- 5. Highway Safety Agency "Computer System Upgrade" Grant: I have submitted for reimbursement on this grant program.
- 6. NH Fish & Game "Wheeled OHRV Enforcement Grant 2011-2012" Now that the trails have reopened, we will conduct several 5 hour patrols on this grant program, utilizing Chief Pushee's personal OHRV, through the end of June.


## JUVENILE ACTIVITY:
