

MONTHLY REPORT**May 2011****NEWS:**

1. Ofc. Migdal has completed primary field training, and is now working most times on his own, with "call" supervisors.
2. Chief Pushee is continuing the process of reviewing/modifying the Police Policy Manual as time allows.
3. We have executed a Conditional Offer of Employment to an applicant for the open Part-Time Police Officer Position, and are trying to finish up background investigations.
4. Chief Pushee and Ofc. Migdal assisted with interviews of a 16 yr old possible victim at the Child Advocacy Center in Manchester. It was determined that despite the allegations left behind, there is no cause to believe the young adult was in fact victimized.
5. Chief Pushee, Capt. Cavanaugh, and Cadet Sgt. Harrison P. attended a Birthday Party for a 4 year old resident, showing him and his friends our cruisers, video systems, thermal imagers, radios, computers, etc., as well as making an "Eddie the Eagle" firearms safety program presentation.
6. We have received positive fingerprint identification from the State Forensic Lab relating to two November 2007 burglaries on the lake. The suspect was, at the time of the offense, a juvenile, so we are at this time reviewing the case with the prosecutor to determine if we should charge this suspect as an Adult, or as a juvenile who has now reached adulthood.

TRAINING:

1. Department conducted an initial range day for qualifications on handguns and long arms. Still need to finish qualifications on long arms with Ofc. Migdal following more initial training on these defensive tools.
2. Chief Pushee recertified as a Firearms Instructor
3. Chief Pushee recertified to conduct the PSTC Required Physical Agility Testing for all officers hired/certified after Jan 1, 2001.

GRANTS:

1. Highway Safety Agency Grants: SPEED ENFORCEMENT: we continue to work these 3 hour dedicated speeding enforcement patrols under this grant program.
2. Highway Safety Agency Grants: DWI ENFORCEMENT: we have begun working these 5 hour dedicated DWI Enforcement patrols under this grant program
3. Highway Safety Agency Grants: Statewide DWI Hunter Weekends: this application for overtime dedicated DWI based enforcement efforts on 3 weekends this summer has received final approvals.
4. 2010-2011 OHRV Enforcement Grant: We have begun these patrols, focusing on education and enforcement of OHRV Laws and closed trail/land enforcement.
5. 2011-2012 OHRV Enforcement Grant: We have received preliminary approvals for the next round of OHRV Grants, which will provide \$1125 in overtime payments for officers to patrol OHRV Trails between July 1, 2011 and June 30, 2012.
6. We have received grants for "Eddie the Eagle" firearms safety program materials, courtesy of the NH Friends of the NRA. We will be receiving a large supply of Level 1 and Level 2 workbooks, stickers, program DVD's, etc.

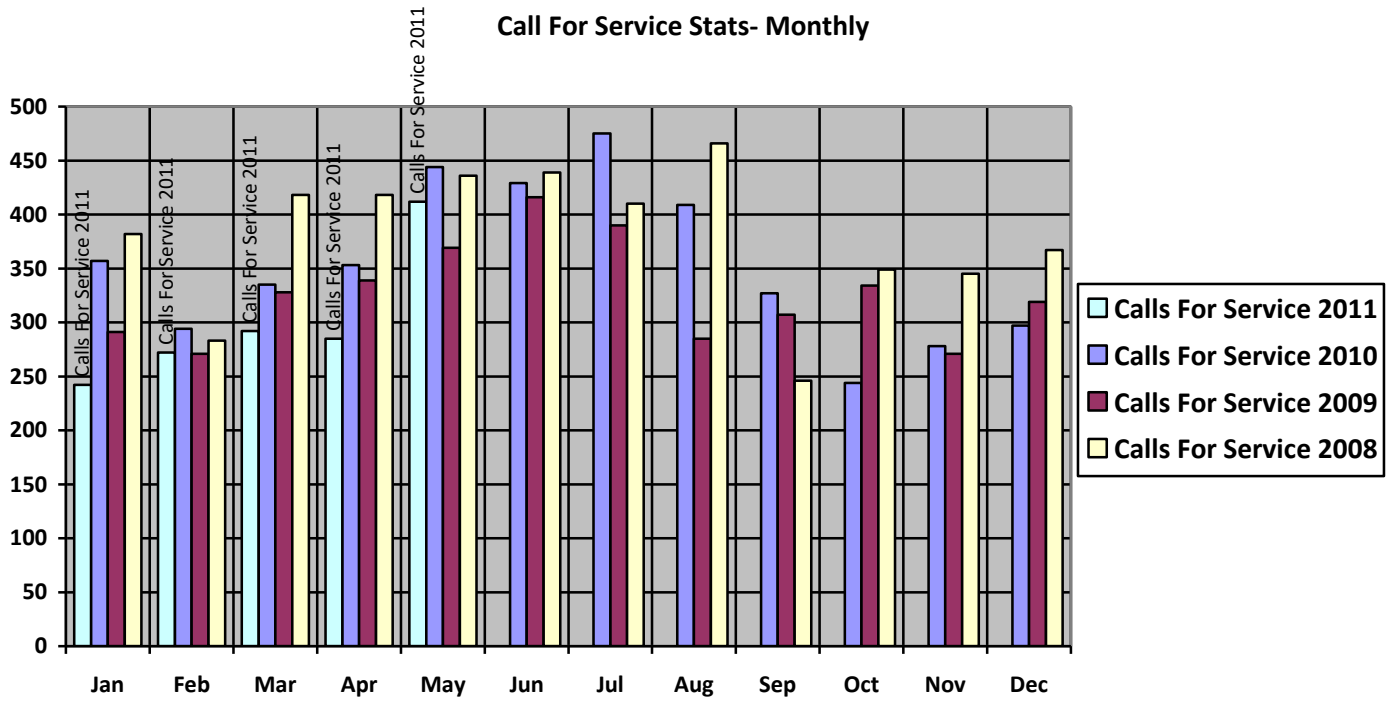
