

**MONTHLY REPORT****April 2016****NEWS:**

1. Members of Cadet Post 612 prepping for Annual Cadet Challenge Weekend first weekend in May.

**TRAINING:**

1. We had to cancel Deering PD Department Training due to schedule conflicts on part of several Part Time Officers.
2. Chief Pushee and Ofc. Bell attended a one day training at the Academy about Dealing with Juveniles who had Mental Illnesses.
3. Chief Pushee, Capt. Cavanaugh, Ofc. Bell, Cpl. Hodgen, and Ofc. Philibert went to PRIMEX for training on the Use-of-Force Simulator.
4. Officers attended Practical Use-of-Force Training Class with Hillsboro PD. Chief Pushee presented block of instruction on Escorts, Arm Bars, and empty hand take downs. There were also blocks on Handcuffing, Ground Defense, and hand-to-hand combat.

**GRANTS:**

1. FY2016 NH Highway Safety STEP Grant: We received final approvals on this grant, and have begun working them. This grant was funded at a lower rate than anticipated, so we will use these sparingly for the time being.
2. FY2016 NH Highway Safety DWI Grant: We received final approvals on this grant, and have begun working them. This grant was funded at a lower rate than expected, but is allowing for approximately 1 such grant per week.
3. FY2017 STEP & DWI Grant Programs: NH-Highway Safety is still in flux, and this year they have already asked for Grant Applications for Federal FY2017, which will run grant programs from October 2016 through September 2017. I have completed applications and sent these in electronically.
4. FY 2016-2017 OHRV Patrol Grants: NH Fish & Game sent grant solicitation for Wheeled OHRV Enforcement Programs. While Deering has received such grants in some past years, we have not received them in the past 4-5 years, and the last time we did, the amount was fairly low. I have mailed in an application, which we should hear about in June. The Grant period would run July 2016 through June 2017.

**JUVENILE ACTIVITY:**

1. We have no Juvenile Diversion Referrals or Court Actions in April 2016.
2. We are preparing JV Petitions to charge a 14 year old male with Drug Violations (at Alt.School).

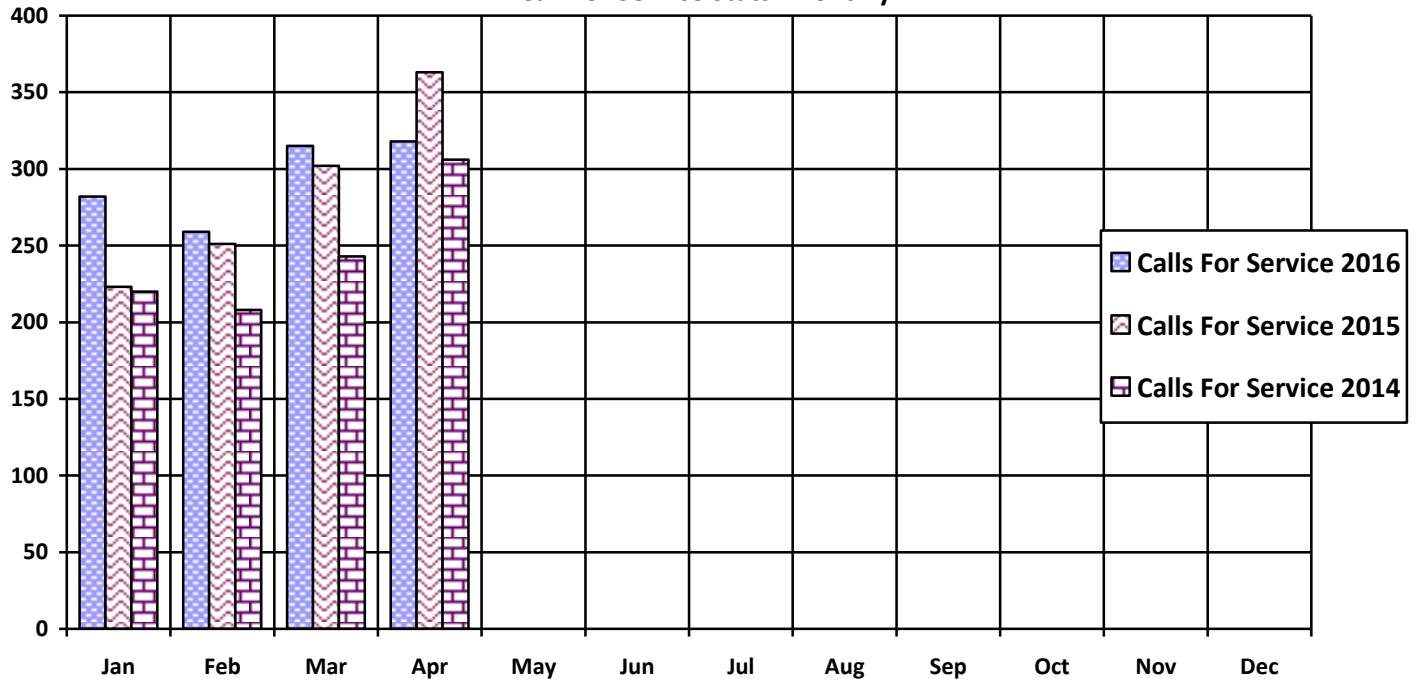
