

MONTHLY REPORT**August 2016****NEWS:**

1. Cadet Post #612 sent several members over to assist with Parking Lots and Traffic Control during the Annual Living History event in Hillsboro.
2. The Town survived the very large Antique Truck Show. I've heard many good reviews of this events. There were minimal LE/Safety Problems that actually arose, but based upon an overview of the events, Chief Pushee put together an After Action Report with several recommendations.
3. School is back in session!!
4. Chief Pushee received notice that we've been preliminarily approved for FY2017 Grant Funding. This funding should become available in October 2016. It includes over \$7K in STEP funding, and over \$7K in DWI funding.
 - a. Note: this years Town Budget was based on already approved grant money. With new changes in approval process at NH Highway Safety, and their budget years going from Oct-Sep each year, this means we will have new Grant Funds available starting in October, AND the NH Highway Safety expects us to start utilizing this, especially in terms of the Safe Commute Days each month. We are not sure how this will work with the current budget, but Chief Pushee will try to building projections for future town budget years.
5. Cruiser Maintenance: Unit 2 LoPro received new brakes. Was also taken to Grappone Ford for transmission service and Suspension Links replacement and a wheel bearing (under our Extended Warranty Protection). Unit 1 HiPro is being scheduled for Tires and Brakes.

TRAINING:

1. The Department once again had to cancel one of our scheduled training session in August, due to scheduling difficulties in gathering a quorum together.
2. Most of the Department did report to the Firearms Range and received Training on Rifles and Handguns. The focus was on tactical reloading of both weapons systems, tactical movements, room entries, and hostage/active shooter response, though we also trained on other basic skills too.
3. Officer Bell was training in the use of NESPIN (New England State Police Informational Network), an intelligence gathering database that we utilize.

GRANTS:

1. FY2016 NH Highway Safety STEP Grant: We received final approvals on this grant, and are continuing to work these.
2. FY2016 NH Highway Safety DWI Grant: We received final approvals on this grant, and are continuing to work these.
3. FY2017 STEP & DWI Grant Programs: I have received notice that we've been preliminarily approved for FY2017 Grant Funding. This funding should become available in October 2016. It includes over \$7K in STEP funding, and over \$7K in DWI funding.
4. FY 2016-2017 OHRV Patrol Grants: We were NOT chosen to received funding under this grant.

JUVENILE ACTIVITY:

1. We are investigating a teen "sexting" issue involving a Deering youth, but are strongly considering sending this through diversion, assuming the issue as we are currently aware of it does not grow into something more involved once forensic analysis of the electronic communication devices used.

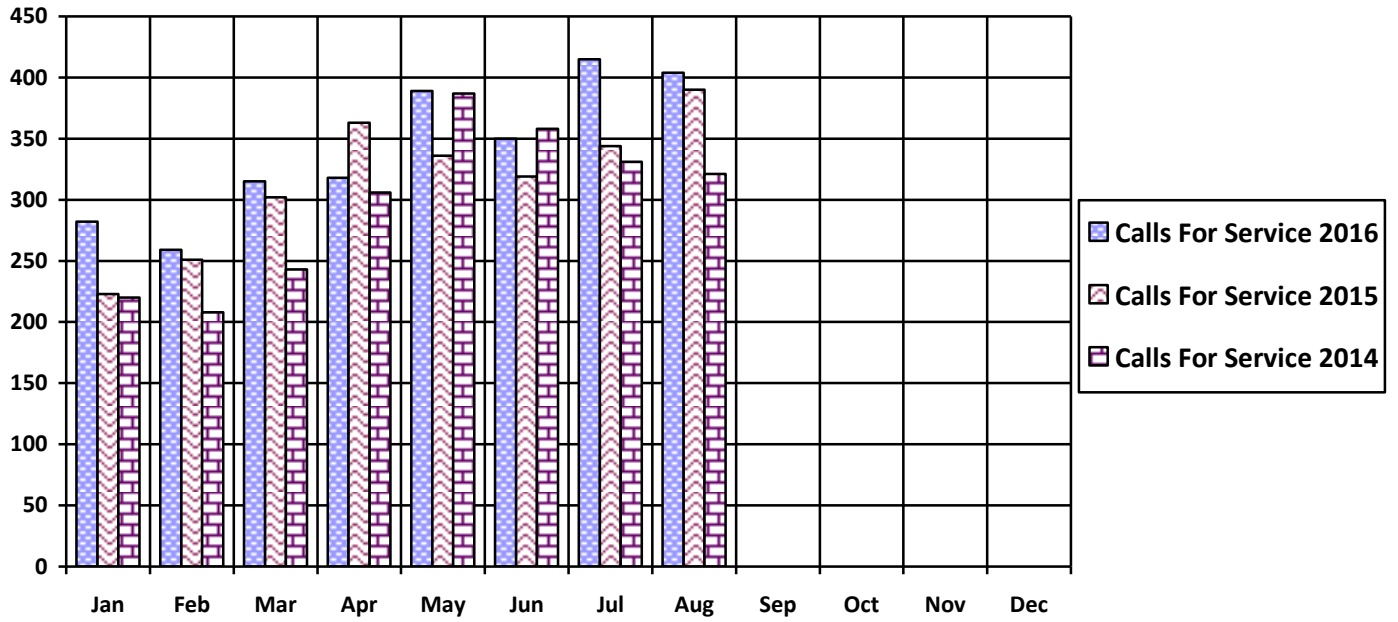
