

**MONTHLY REPORT****AUGUST 2017****NEWS:**

1. 2017 Cruiser is awaiting upfit schedule. Upfitter is just waiting on delivery of new cage and rear cargo weapon storage drawer.

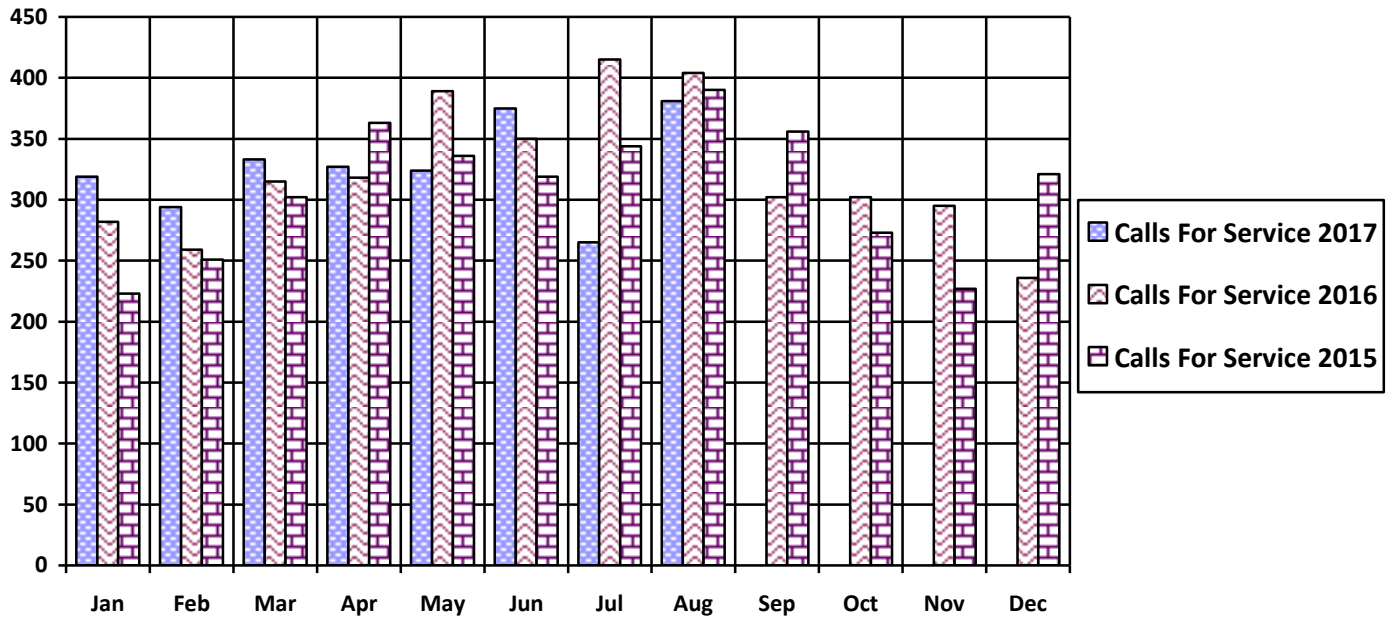
