

MONTHLY REPORT**DECEMBER 2017****NEWS:**

1. Elfin Officer I.B. Coppin came down from the North Pole PD to help us out again this Holiday Season. He did a great job and was very helpful again this year, but is now off for his 11 month long vacation.
2. We have positively identified suspect and are working on filing warrants in relation to one of our late summer burglaries. This suspect is the primary suspect in at least 2 other burglaries in the same time frame and same section of town, but we have not yet gotten enough evidence to charge him in those cases. The suspect's brother HAS been charged with Receiving Stolen Property, as he was allowing the suspect to live in his house, bring the stolen property in, and "melt" it down for criminal sale.

TRAINING:

1. Capt. Cavanaugh, Ofc. Bell, and Ofc. Forsley all attended a training session at the Police Academy to learn about Financial Exploitation of the Elderly.
2. Ofc. Bell and Ofc. Forsley both attended a training session at the Police Academy to become certified to administer the 3 Year Physical Agility Testing that is required of all officers hired after 1Jan2001.

GRANTS:

1. 2018 STEP Grant Program : We have begun working these grants, but since our approved amount was cut so significantly, we will be using these sparingly through the next few months, where the winter roads usually help us with some of the speeding issues in town.
2. 2018 DUI Grant Program: We are schedule to work some of these grants through the Statewide Drive Sober Enforcement weeks around the Christmas/New Years holiday periods. Due to cuts in the approved grant amounts, we will be using these cautiously through the winter months.
3. 2018 Distracted Driving Program: We not started using these yet, but will begin scheduling these patrols more in the spring time when traffic picks up.
4. 2018 Highway Safety Equipment Grant: I heard informally that this grant was going to be approved, BUT I still have not seen any actual approval paperwork come through on it yet.

JUVENILE ACTIVITY:

1. We have a JV Case that is going to be taken through the court system. It is related to an assault incident, and is actually being charges as a false report. The JV suspect has a history of involvement in violent crimes, and we will likely have the prosecutor urge the court to address the suspect as an adult.

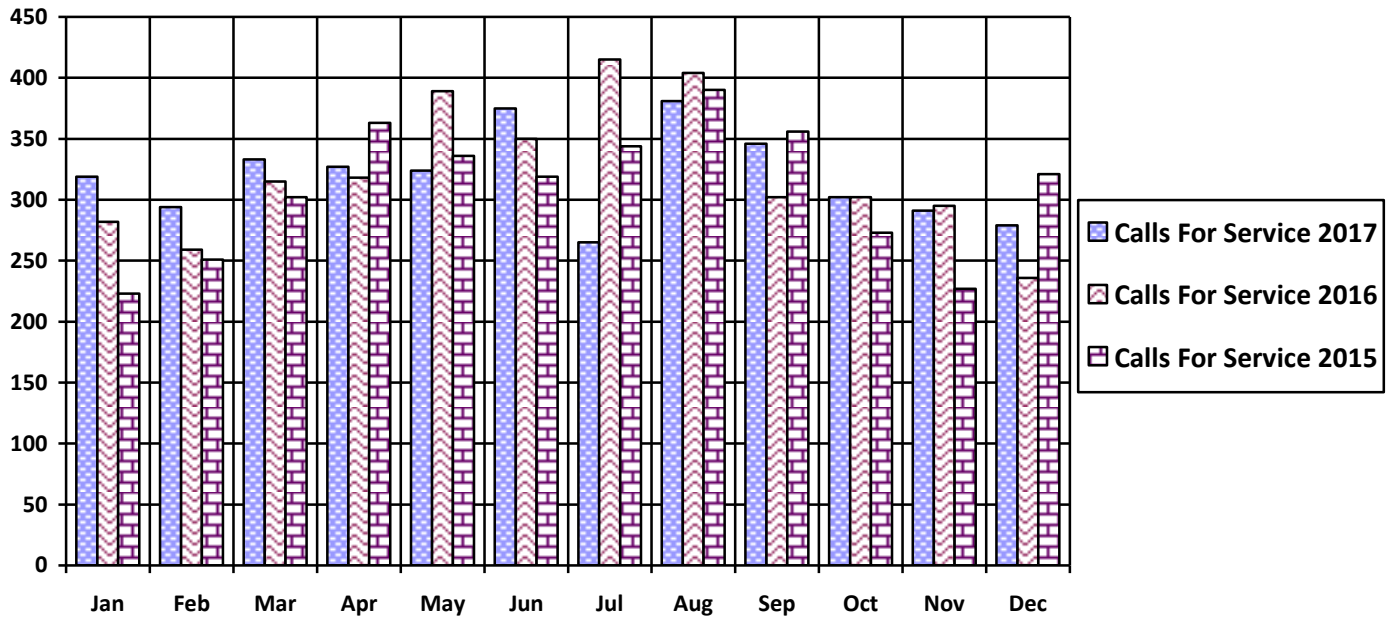
