1. FT Recruit Officer Bennett is slated to complete the Police Academy on April 11<sup>th</sup>.

**TRAINING:**

1. Chief Pushee helped at the Police Academy for two days training the current FT Recruit Class the finer points of Police Expandable Baton use.
2. PD completed "part 1" of our annual 4 hour Use-of-Force Classroom requirement.
3. PT Officer Rackett continues in-house Field Training until his Part Time Academy starts (hopefully in June).

**GRANTS:**

1. Highway Safety Agency Grants:
  - a. OPERATION SAFE COMMUTE: We continue to work this grant one (specified) day each month. This will compliment the morning and afternoon commute times with an extra officer dedicated to MV Safety Enforcement Patrols for one specified day each month.
  - b. SPEED Patrol Grant: This grant has received "pre-approvals" for 87 hrs of OT patrols. Final approvals should be coming within a few weeks.
  - c. DWI Patrol Grant: This grant has received "pre-approvals" for 85 hrs of OT patrols. Final approvals should be coming within a few weeks.
  - d. CRUISER VIDEO GRANT: This grant has received "pre-approvals" for the federal share of matching funds. Final approvals should be coming within a few weeks.

**JUVENILE ACTIVITY:**

1. We had NO Juvenile Diversion cases this month, BUT we may be sending one through Court on a CHINS (Child In Need of Services) Petition.

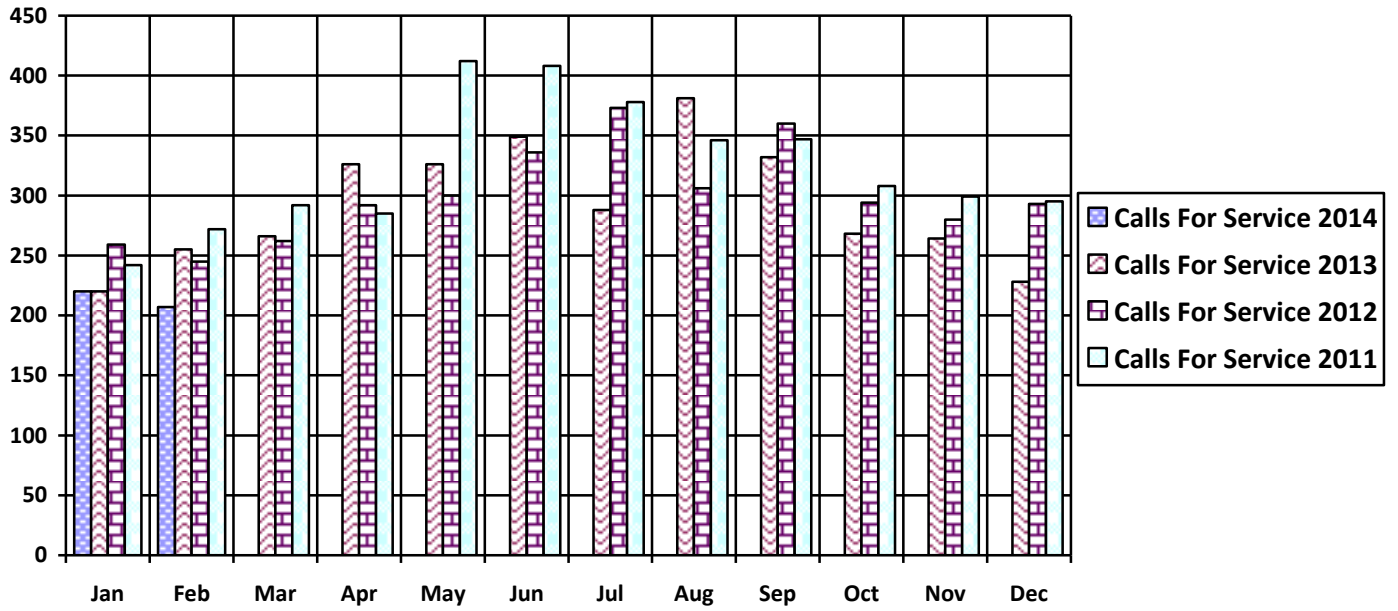
