# MONTHLY REPORT

# **July 2016**

#### **NEWS:**

- 1. Chief Pushee was off for vacation for 2 weeks during the end of July. A little more than ½ of this was spent at his parents cabin in the Adirondacks truly on Vacation, while the other time was at home working on a bedroom remodeling project. He returned to duty on July 31<sup>st</sup> to start trying to catch up on everything that occurred since he left.
- 2. During the Hillsboro Balloon Fest, various members of the Hillcat Police Explorer Post 612 provided Traffic Control, Parking Lot Services, Security Patrols, and Community Policing Services for this Annual Event. Our members provided almost 90 hours total of Community Service, and Chief Pushee and assistant advisors provided another 22 hours of Community Policing time while Supervising this Cadet Detail.

### TRAINING:

- 1. We had to cancel a scheduled training event in early July due to several of our Part Time Officers having schedule conflicts.
- 2. The Department is scheduled for 2-3 days of training in August, including Police Baton annual recertification and Firearms Training (as opposed to Firearms Qualifications, which are mostly complete for the year).

### **GRANTS**:

- 1. FY2016 NH Highway Safety STEP Grant: We received final approvals on this grant, and are continuing to work these.
- 2. FY2016 NH Highway Safety DWI Grant: We received final approvals on this grant, and are continuing to work these.
- FY2017 STEP & DWI Grant Programs: I previously submitted my grant applications for the federal fiscal year 2017 (Oct 2016 through Sept 2017).
   Recently I was advised by NH Highway Safety that they needed me to re-submit to a lower threshold of funding. I made the requested adjustments to the patrol plans.
- 4. FY 2016-2017 OHRV Patrol Grants: We have not heard about this funding possibility yet.
- 5. Distracted Driving Grant: Chief Pushee did NOT have a chance to complete applications for this grant, due to call volume and duty assignment needs prior to his departure for vacation.

### JUVENILE ACTIVITY:

1. We are investigating a teen "sexting" issue involving a Deering youth, but are strongly considering sending this through diversion, assuming the issue as we are currently aware of it does not grow into something more involved once forensic analysis of the electronic communication devices used.


