# MONTHLY REPORT

## July 1<sup>st</sup> to 31<sup>st</sup>, 2015

#### **NEWS:**

- 1. 2014 Cruiser struck a Deer during patrols on July 4<sup>th</sup>. It is still in process of being fixed. Insurance is covering all but \$1K deductible.
- 2. Chief Pushee took nearly 2 weeks of vacation, traveling with family to parents camp in Adirondacks.
- 3. Officer Bell has continued his Field Training, but is starting to take his own solo shifts now.
- Chief Pushee and Advisor Hargreaves will be leaving with members of the Cadet Post #612 for a summer Super Tour of Washington, DC, very early in the morning on August 5<sup>th</sup>, and returning late in the evening on August 8<sup>th</sup>.

#### **TRAINING:**

- 1. Chief Pushee & Capt. Cavanaugh completed the required Use-of-Force Classroom Training with Officer Bell.
- All members of the Department went through Annual Firearms Qualifications for handguns, rifles, and shotguns during two afternoons of Firearms Range Qualifications. We will now start scheduling and focusing on actual "firearms training." We are planning tactical training, night time training, movement training, etc.

#### **GRANTS**:

- 1. Highway Safety Agency Grants:
  - a. OPERATION SAFE COMMUTE 2014-2015: We continue working these patrols once a month.
  - b. SPEED ENFORCEMENT: We have begun working these patrols, and Chief Pushee submitted quarterly reports and reimbursement requests
  - c. DWI ENFORCEMENT: We have begun working these patrols, and Chief Pushee submitted quarterly reports and reimbursement requests
  - d. TRAFFIC SIGN/SIGNALS: We have begun working these patrols, and Chief Pushee submitted quarterly reports and reimbursement requests
- 2. TIRE DEFLATION DEVICES: Chief Pushee is waiting for a copy of the canceled check from the payment, and then will submit for reimbursement.
- 3. Chief Pushee attended the "Partners Meeting" in Concord for the NH Highway Safety Grant Programs. It looks as if the noisy wheels, starting with Chief Pushee's correspondence with the NH-HAS (which got passed to NH-DOS and NHTSA (National), and was followed up by Selectman's Letter to various governmental agencies, had at least some effect. They are saying now that we will "most likely" be eligible to apply for a "Group II/Second Round" grant award, upon a competitive merit based application process which should open in January 2016'ish. But we don't know how much this might be for.

1. We have no Juvenile Diversion Referrals or Court Actions in July 2015.


