# **MONTHLY REPORT**

# JULY 2013

#### **NEWS:**

- 1. Chief Pushee on vacation with family for 2 weeks. Capt. Cavanaugh filling in, working the same "ungodly" hours that Chief's been working for a while (55+ hour workweeks plus dozens of hours on call) THANK YOU TOM.
- 2. New SUV Cruiser- We picked up the new 2013 Ford Interceptor Utility SUV from Imperial Municipal Partners on July 31<sup>st</sup>. We are hoping that Beltronics will be ready to outfit it very soon, and then will schedule with Maineline Graphics for vinyl markings. 2003 Ford Expedition was traded in.
- 3. We have conducted Applicant Testing for Police Officers and are working on scheduling an Interview Process. We had 11 people participate in the testing process.
- 4. Because of being short-staffed and Chief Pushee's vacation, State Police were in "on-call" status for us during various times in July. They often are not answering any calls except for "in-progress" emergency criminal cases though, and everything else that is past-tense or deemed no a criminal or emergency case in nature is being held back for us to follow up on later.
- 5. I have entered the town deeded properties (as provided to me) into our Community Policing Logs for officer house/building checks while on patrol.

### **TRAINING:**

- 1. We had no PD training this month because of vacation schedules and some last minute call volume issues that caused us to cancel, last minute, the training date we did have scheduled.
- 2. We have 2 training dates scheduled in the last two weeks of August.

### **GRANTS**:

- 1. Highway Safety Agency Grants:
  - a. OPERATION SAFE COMMUTE: This grant program is being worked. Special Traffic Safety Patrols during Morning and Afternoon Commute hours. Chief Pushee has been submitting quarterly reports and reimbursement as they come due.
  - b. SPEED Patrol Grant: This grant is being worked. It consists of 30 three hour patrols specifically targeting speeding vehicles during commute hours on primary roadways. Chief Pushee will be submitting monthly reports and quarterly reimbursement requests at the appropriate times.
  - c. DWI Patrol Grant: This grant is being worked. It consists of 18 five hour patrols specifically directed at locating drugged and drunk drivers on our roadways. Chief Pushee will be submitting monthly reports and quarterly reimbursement requests at the appropriate times.
    - VIDEO Grant: The invoice has been submitted for payment. Once we have the cancelled check I can submit for reimbursement
      - We will need to wait for new federal grant budget (October) to apply for funding for 2<sup>nd</sup> Video Unit as previously discsd.


