

MONTHLY REPORT**June 1st to June 28th, 2015****NEWS:**

1. 2013 Cruiser had the door skins fixed again at Grappone, for no charge, although there was a charge to fix a paint peeling issue on the tailgate.
2. Steve Bell has been hired, and has started administrative duties and FTO. He is ready to be Sworn In tonight.
3. We have received the LIDAR unit that was ordered. Chief Pushee has received a brief training from Hillsboro PD Officer McSweeney, but will be looking into certification classes as well.

TRAINING:

1. Chief Pushee attended a training in employee law updates during the NH Chief's of Police Seminar and Trade Show.
2. Chief Pushee assisted at the Police Academy by teaching the Expandable Police Baton course to the recruits from the 168th Full Time Police Academy.

GRANTS:

1. Highway Safety Agency Grants:
 - a. OPERATION SAFE COMMUTE 2014-2015: We continue working these patrols once a month.
 - b. SPEED ENFORCEMENT: We have begun working these patrols, and Chief Pushee submitted quarterly reports and reimbursement requests
 - c. DWI ENFORCEMENT: We have begun working these patrols, and Chief Pushee submitted quarterly reports and reimbursement requests
 - d. TRAFFIC SIGN/SIGNALS: We have begun working these patrols, and Chief Pushee submitted quarterly reports and reimbursement requests
2. TIRE DEFLATION DEVICES: We have received these stop sticks. Chief Pushee will be submitted the invoice for payment, and once the check is cashed by StopStick LTD, we can submit for reimbursement of half the cost. We plan to conduct training classes in these prior to placing them into service.
3. Highway Safety Agency Grant Programs are being "restructured" and it doesn't appear Deering will be eligible to apply for patrol grants for next budget year. Chief Pushee will be attended a meeting on July 16th in Concord, though it appears the decisions have already been made about this issue.

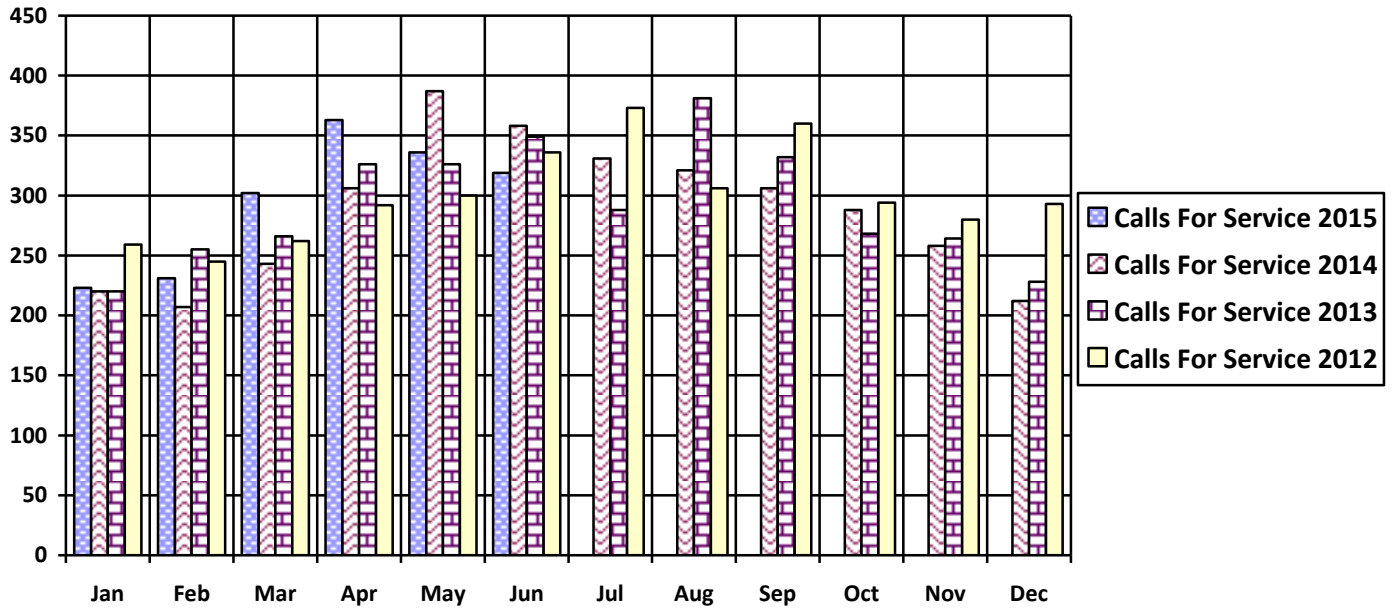
