GRANTS:

1. Highway Safety Agency Grants:
 - a. OPERATION SAFE COMMUTE: We continue to work this grant one (specified) day each month. This will compliment the morning and afternoon commute times with an extra officer dedicated to MV Safety Enforcement Patrols for one specified day each month.
 - b. SPEED Patrol Grant: This grant reached final approval and we have begun working some of these additional patrols.
 - c. DWI Patrol Grant: This grant reached final approval and we have begun working some of these additional patrols.
 - d. CRUISER VIDEO GRANT: This grant has reached final approvals. We are waiting for approval from BOS to order the unit. Once we have received it and paid the invoice, we can submit for reimbursement up to 50% of the costs.

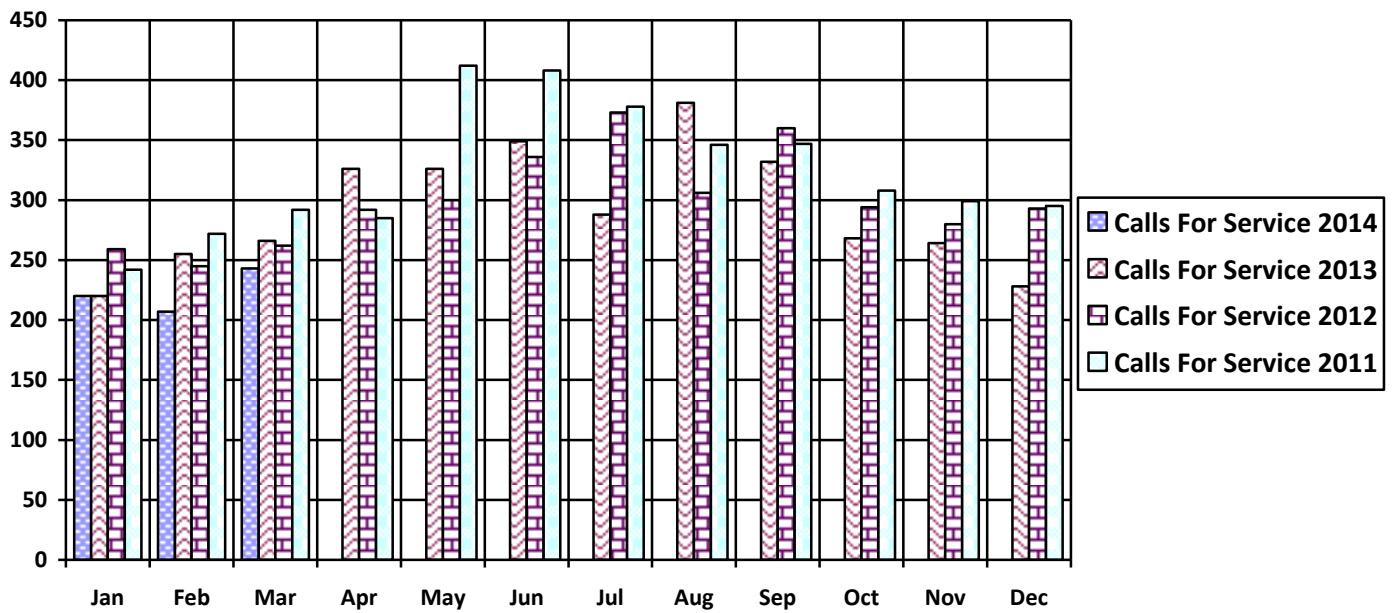
