

**MONTHLY REPORT****March 2016****NEWS:**

1. Members of Cadet Post 612 assisted with Traffic/Parking/Safety Patrols during Town Voting and Town Meeting.

**TRAINING:**

1. We had to postpone March Department training due to several conflicts with part time officer staff.
2. In March we will be training on Driving/Use-of-Force Simulator at Primex in Concord.

**GRANTS:**

1. FY2016 NH Highway Safety STEP Grant: We received final approvals on this grant, and have begun working them. This grant was funded at a lower rate than anticipated, so we will use these sparingly for the time being.
2. FY2016 NH Highway Safety DWI Grant: We received final approvals on this grant, and have begun working them. This grant was funded at a lower rate than expected, but is allowing for approximately 1 such grant per week.
3. FY2017 STEP & DWI Grant Programs: NH-Highway Safety is still in flux, and this year they have already asked for Grant Applications for Federal FY2017, which will run grant programs from October 2016 through September 2017. I have completed applications and sent these in electronically.
4. FY 2016-2017 OHRV Patrol Grants: NH Fish & Game sent grant solicitation for Wheeled OHRV Enforcement Programs. While Deering has received such grants in some past years, we have not received them in the past 4-5 years, and the last time we did, the amount was fairly low. I have mailed in an application, which we should hear about in June. The Grant period would run July 2016 through June 2017.

**JUVENILE ACTIVITY:**

1. We have no Juvenile Diversion Referrals or Court Actions in March 2016.
2. We assisted with a JV Case Investigation relating to Deering Youths, but the offenses appear to have occurred in Hillsboro, so we ceded jurisdiction to the Hillsboro Police Dept. on this issue.

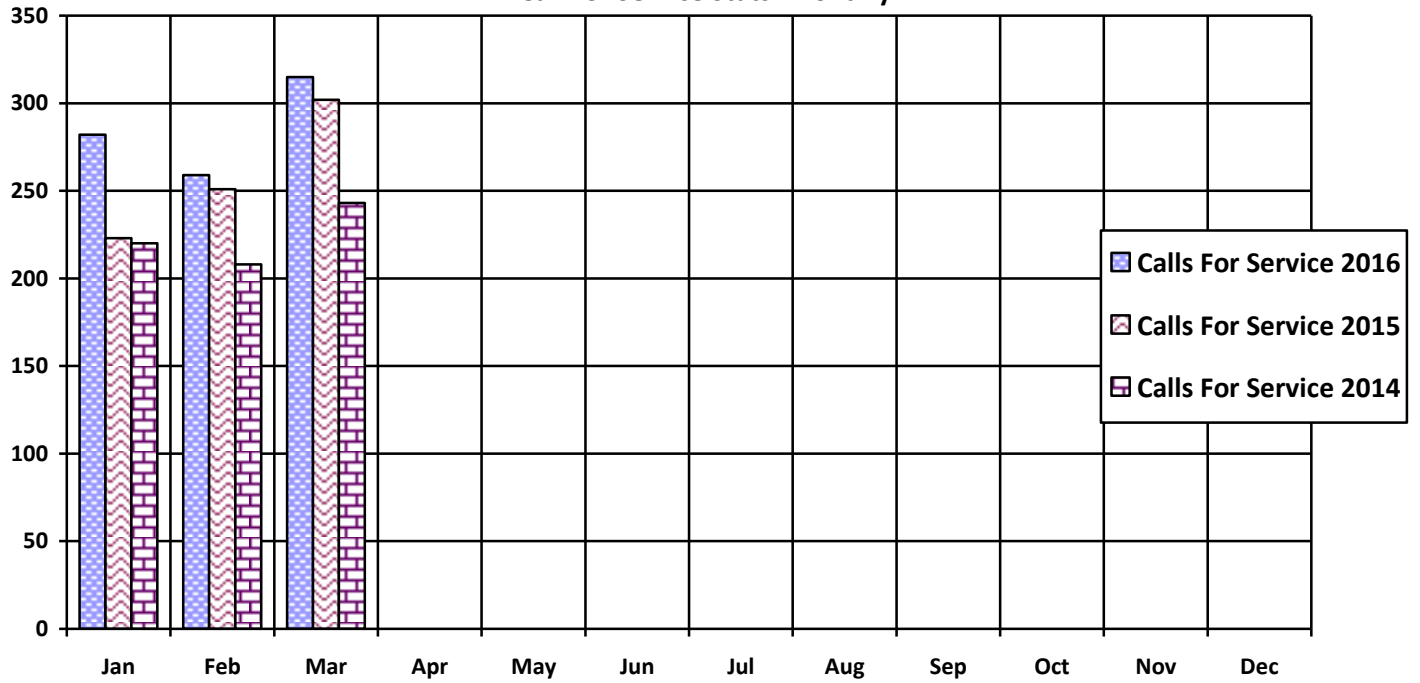
