

**MONTHLY REPORT****May 2013****NEWS:**

1. Internships: We continue to sponsor two High School Interns.
2. Expedition is suffering a probably brake issue (smoking when driven). Will not fix if it's going to cost too much)
3. Impala was fixed and is due for re-stripping with Mainline Graphics first week of June.
4. We have placed Ads on Local Govt. Center website, NH Sunday News (2 Sundays), and through connections at NEC Criminal Justice program for anticipated openings for Full Time and Part Time Police Officers.

**TRAINING:**

1. The PD held "Part 2" of Annual 4 hours Use-of-Force Classroom training.
2. Due to scheduling issues, we had to postpone Firearms Qualifications from May to early June.
3. We have 2 training sessions scheduled in June. It has been tough getting schedules to mesh for these.

**GRANTS:**

1. Highway Safety Agency Grants:
  - a. OPERATION SAFE COMMUTE: This grant program is being worked. Special Traffic Safety Patrols during Morning and Afternoon Commute hours. Chief Pushee has been submitting quarterly reports and reimbursement as they come due.
  - b. SPEED Patrol Grant: This grant is being worked. It consists of 30 – three hour patrols specifically targeting speeding vehicles on primary roadways. Chief Pushee will be submitting monthly reports and quarterly reimbursement requests at the appropriate times.
  - c. DWI Patrol Grant: This grant is being worked. It consists of 18 – five hour patrols specifically directed at locating drugged and drunk drivers on our roadways. Chief Pushee will be submitting monthly reports and quarterly reimbursement requests at the appropriate times.
  - d. VIDEO Grant: The invoice has been submitted for payment. Once we have the cancelled check I can submit for reimbursement
    - We will need to wait for new federal grant budget (October) to apply for funding for 2<sup>nd</sup> Video Unit as previously discsd.
2. Portable Radio Grant #2 – The newest portable radio is back. Our chosen "upfitter" programmed this for us a no charge (\$275 savings).
3. Fish & Game Agency- OHRV Enforcement Grant: We just received notification that we were NOT approved for this grant. Due to budget cuts, this program was dramatically slashed. Only 15 of 36 applications were funded at all, with the largest grant approved being less than \$2500 total.


