

MONTHLY REPORT**NOVEMBER 2017****NEWS:**

1. 2017 Cruiser is completely done and on the road. The invoices have been submitted.
2. Officer I.B. Coppin Elf returned on December 4, 2017 from his 11 month vacation. He will be helping out through the end of the Holidays.
3. Cadet Advisor James Hargreaves was awarded the Silver E Award by the Daniel Webster Council of the BSA for his outstanding service as a Volunteer Advisor to our Hillcat Police Explorers from Post 612. Advisor Hargreaves is a former Deering PD part-time Officer who resigned in 2012, but stayed on as a volunteer to help with the Cadets ever since, and he is an invaluable member of our Police Department.
4. Cadet Captain Tyler D. was one of three Explorer Scouts in NH that was awarded the "Explorer of the Year" award by the Daniel Webster Council of the BSA. Tyler is a Senior at HDHS, and has been a member of the Hillcat Police Cadets for four years. In that time he has given well over 275 hours of Community Service time to help the Department and the Cadet Post serve Deering and our surrounding communities.

TRAINING:

1. Most members of the Department went through an online training module addressing changes in the Marijuana Laws and how these change the way the NH State Forensic Laboratory wants Drug Crime Evidence recorded and submitted for Laboratory Analysis and Certification.
2. Capt. Tom Cavanaugh and Officer Steve Bell attended a training session at the NH Police Academy focused on Investigating Non-Fatal Strangulation crimes. This ended up being a timely training class, because in the past year, the Department has investigated two cases that involved attempted strangulations. (Felony 2nd Degree Assaults).
3. Chief James Pushee attended a training session at the NH Police Academy focused on Advanced Stress Management for Law Enforcement Supervisors.

GRANTS:

1. 2018 STEP Grant Program : We have begun working these grants, but since our approved amount was cut so significantly, we will be using these sparingly through the next few months, where the winter roads usually help us with some of the speeding issues in town.
2. 2018 DUI Grant Program: We are schedule to work some of these grants through the Statewide Drive Sober Enforcement weeks around the Christmas/New Years holiday periods. Due to cuts in the approved grant amounts, we will be using these cautiously through the winter months.
3. 2018 Distracted Driving Program: We not started using these yet, but will begin scheduling these patrols more in the spring time when traffic picks up.
4. 2018 Highway Safety Equipment Grant: I heard informally that this grant was going to be approved, BUT I still have not seen any actual approval paperwork come through on it yet.

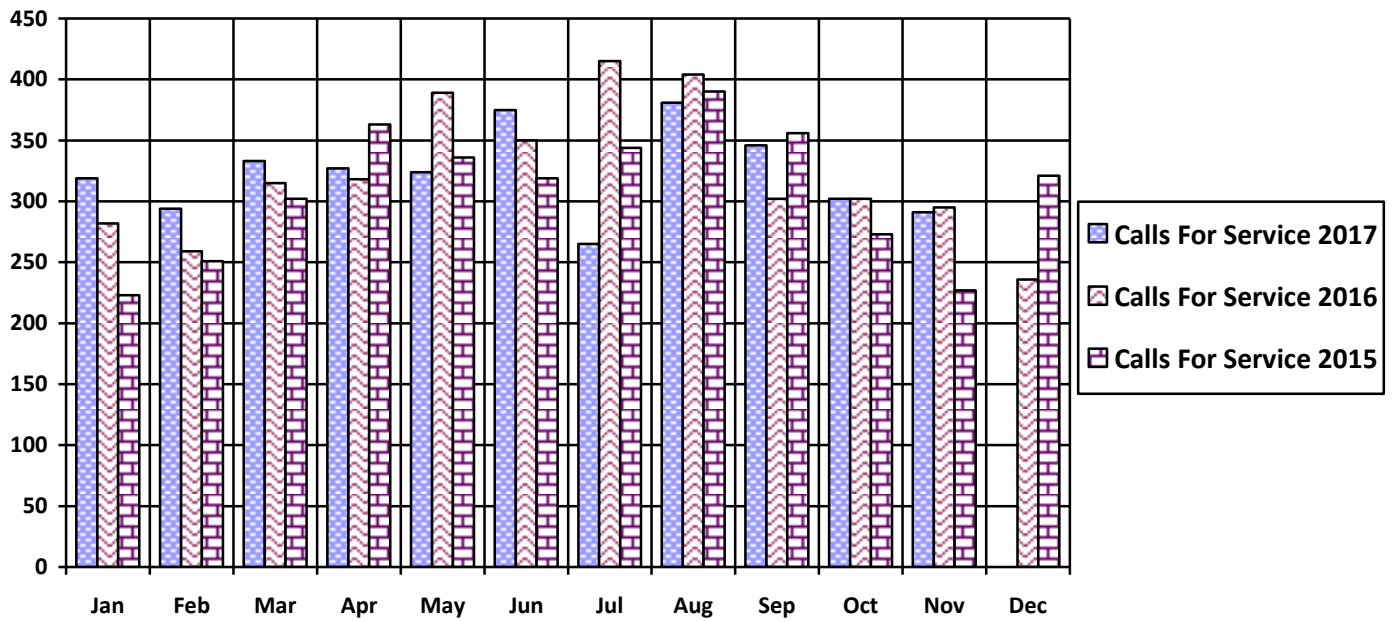
