1. PD and the Cadets conducted our Annual Trick-or-Treating Safety Detail in the Longwoods Mobile Home Park, handing out about 100 bags of goodies and public/traffic safety educational fun stuff.

GRANTS:

1. FY2016 NH Highway Safety STEP Grant: This is the Sustained Traffic Enforcement Program Grant, which consolidates the Safe Commute, the Speed, and the Traffic Signals grant programs. The Application was sent in September 2015. We are still awaiting word on the review process.
2. FY2016 NH Highway Safety DWI Grant: The Application was sent in September 2015. We are still awaiting word on the review process.
3. Bulletproof Vest Program: Chief Pushee has submitted for reimbursement through the online receipt process.
