 - c. DWI Patrol Grant: Chief Pushee is trying to find the time to prep the applications for the next round of this grant program.
 - d. CRUISER VIDEO GRANT: this application has been sent in to Highway Safety and Chief Pushee is awaiting its return for town approval. The review and hopeful approval is awaiting the release of federal monies to the NH Highway Safety Agency.

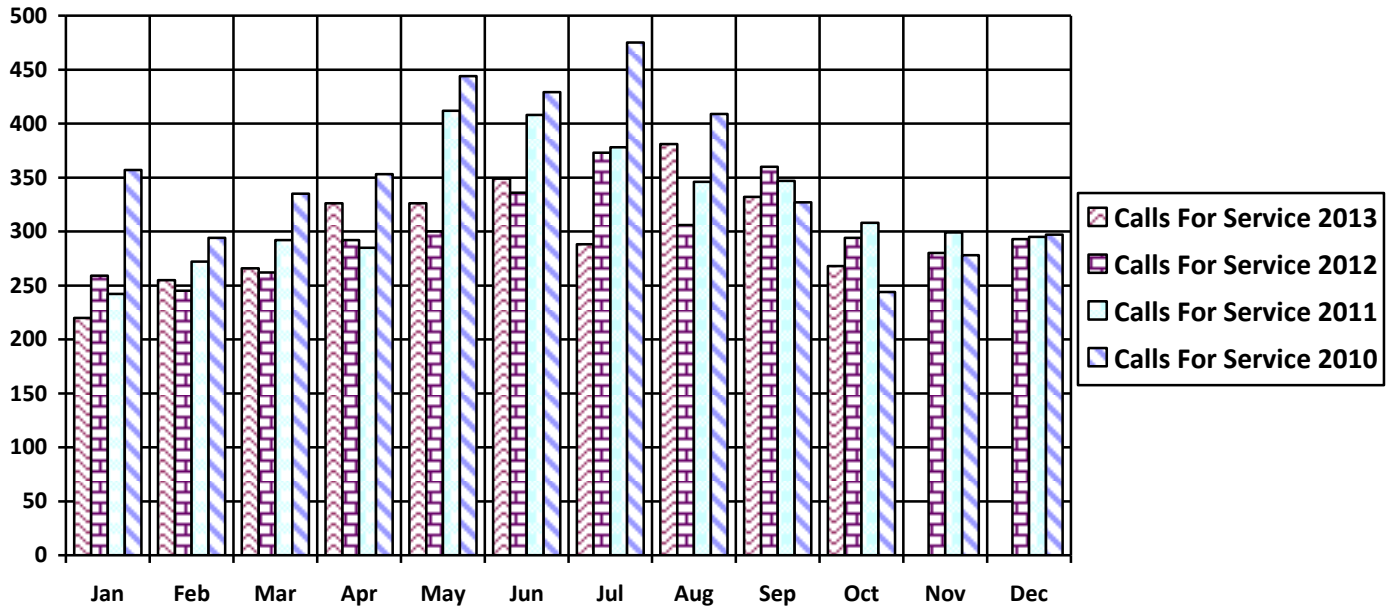
