

MONTHLY REPORT**Oct. 1st to Oct. 31st, 2014****NEWS:**

1. Cruiser Maintenance: Both cruisers have been oil undercoated. Unit 2 (LoProfile) is prepped for winter with installation of snow tires and the new mud flaps during last oil change. Unit 1 (HiProfile) will be similarly prepped during next oil change, once we get new winter snow tires and spare rims.
2. Unit 1 (HiProfile) suffered minor damage on October 31st, when it was backed into a rock while turning around on a dark section of roadway. We are obtaining estimates for repairs.
3. We have concluded the Background Investigation on new Police Officer Applicant Ethan Vaillancourt, and are prepared to go forward with hiring.
4. Police Dept., Fire-Rescue Dept., and Police Cadets held their annual Public Safety Day on October 4th. This was fairly well attended even though it was a misty/rainy day. Many thanks to F.F. Chrissy Elliott for all the work she put into to helping set this up.
5. Cadets and PD handed out more than 100 "goodie bags" during our annual Halloween Detail at the Longwoods Mobile Home Park. This has become a pseudo "destination" for trick-or-treaters because the area is limited access and the PD/Cadets set up and specifically patrol the area for safety of the little ones. This year the Fire Dept. joined us for the first time, albeit on the opposite side of the park to cover that corner, bringing in a BRT and Sparky the Fire Dog.

TRAINING:

1. Chief Pushee and Capt. Cavanaugh qualified on their new issue duty weapons. We traded in the Department's very aged Glock Model 23 handguns for new model Glock M19 handguns. After trade-in, the cost for the new handguns was about \$110 each. We are waiting for the adjusted invoice showing the trade value.
2. Chief Pushee spent two days assisting at the Police Academy teaching Expandable Baton to the Full Time Officer Recruit class.
3. Capt. Cavanaugh spent three days in Brookline, NH, taking a class on Investigations & Statement Analysis.

GRANTS:

1. Highway Safety Agency Grants:
 - a. OPERATION SAFE COMMUTE 2014-2015: We are working this grant one day each month, as assigned by the NH Highway Safety Agency. This grant provides an officer specifically for traffic safety enforcement efforts during the commuter hours.
 - b. Chief Pushee is seeking permission to begin the process of writing and applying for the next round of Speed and DWI Grants. These will provide reimbursement for Overtime Costs, including the related employee benefits, for additional officers to be placed on directed enforcement patrols during certain specific known traffic patterns.

JUVENILE ACTIVITY:

1. We are investigating a Juvenile Case that was brought to our attention in late October, and intend to file Juvenile Petitions with the court within the next week or two.

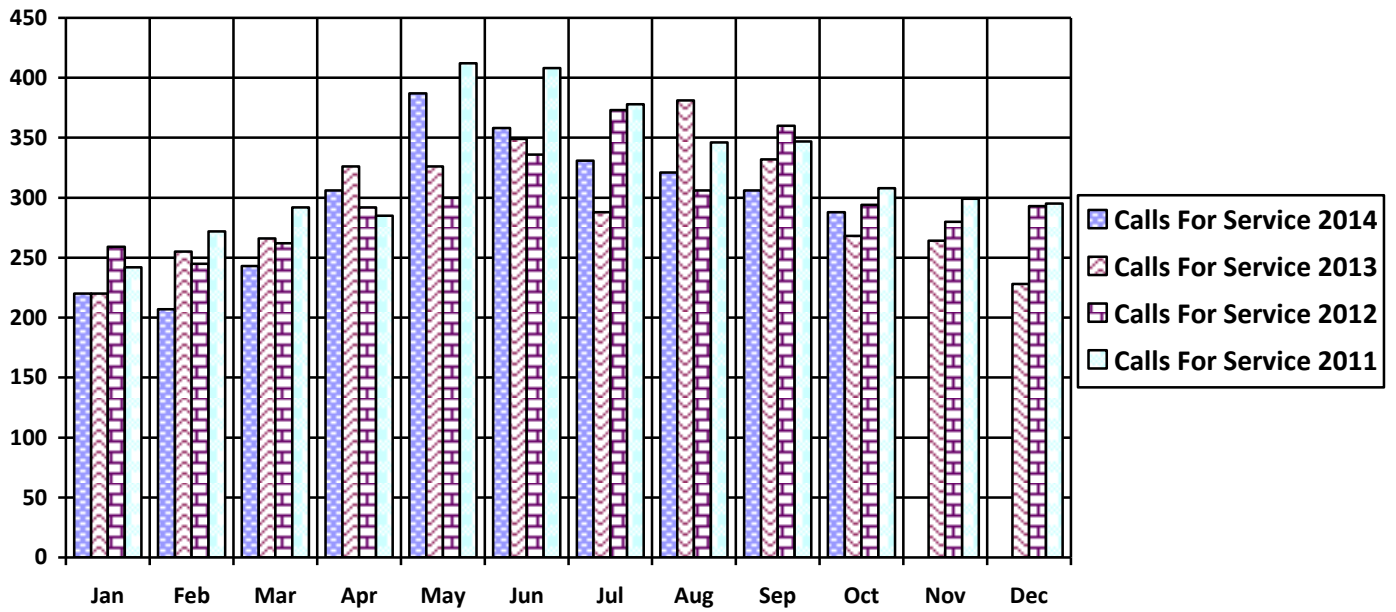
