TRAINING:

 - d. CRUISER VIDEO GRANT: this application has been sent in to Highway Safety and Chief Pushee is awaiting its return for town approval. We are hoping that the government shutdown does not delay Highway Safety Grant Funding for programs such as this.

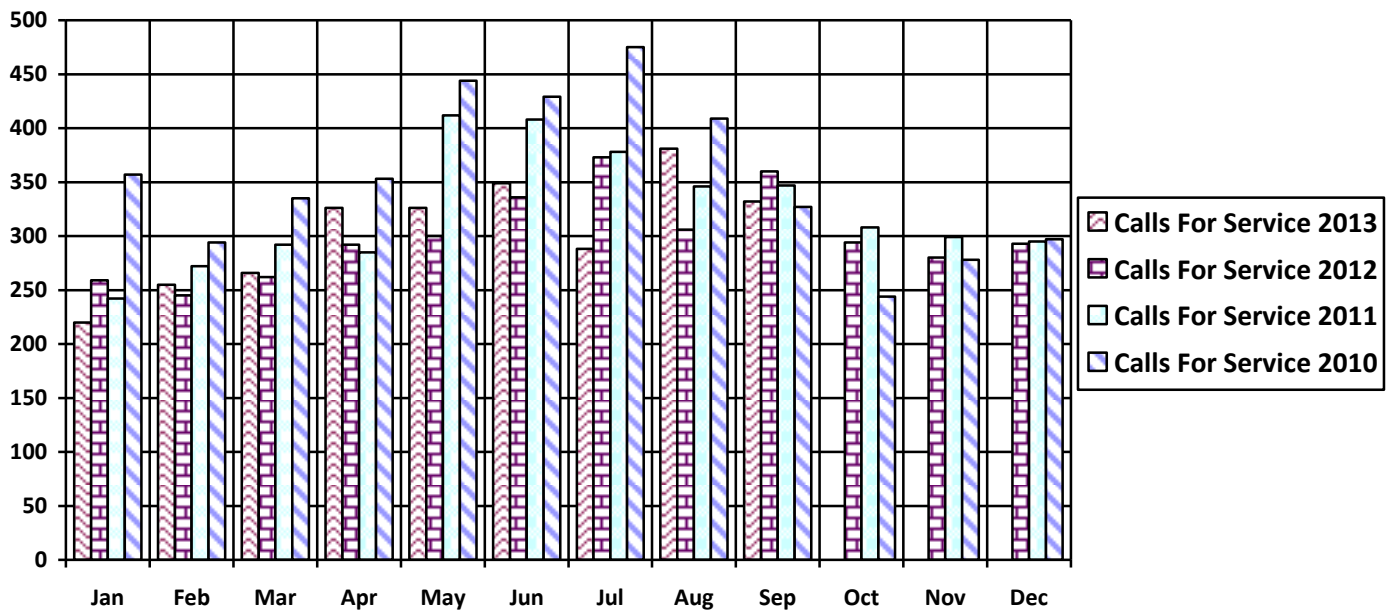
