

MONTHLY REPORT**October 2012****NEWS:**

1. Police Cadets helped with prep for and then with our 10th Annual Halloween Trick-or-Treating Detail in Longwoods Mobile Home Park. We handed out about 120-130 goodie bags, as well as provided site security patrols through park and surrounding wooded areas and trails during this 4 hour event.
2. Cadet Harrison P. assisted Chief Pushee with Hurricane Sandy response by "riding along" during the worst parts of the storm, helping clear limbs and debris, check outages, etc.

GRANTS:

1. Highway Safety Agency Grants:
 - a. OPERATION SAFE COMMUTE: This grant program has started for 2012-2013 season. It will entail two 3 hour shifts during commute time on one specific day each month, in conjunction with most other departments statewide.
 - b. SPEED Patrol Grant: Chief Pushee will be looking to begin application process for the next series of this grant soon.
 - c. DWI Patrol Grant: Chief Pushee will be looking to begin the application process for the next series of this grant soon.
2. Portable Radio Grant – NH Department of Safety: Our new portable radio has been received back from programming and is in use. Chief Pushee will be submitting paperwork for reimbursement of the programming costs.
3. 1033 Defense Reutilization Program: nothing recently on this grant, though the program is undergoing "login/sign-in" changes that are requiring some new forms and online passwords, which Chief will get to once he catches on other duties.

JUVENILE ACTIVITY:

2. Capt. Cavanaugh has reviewed the Goffstown Diversion group's information. He finds that in most instances, this program seems similar to the Merrimack County program. As it is "in county" we will be considering this program in future diversion cases.

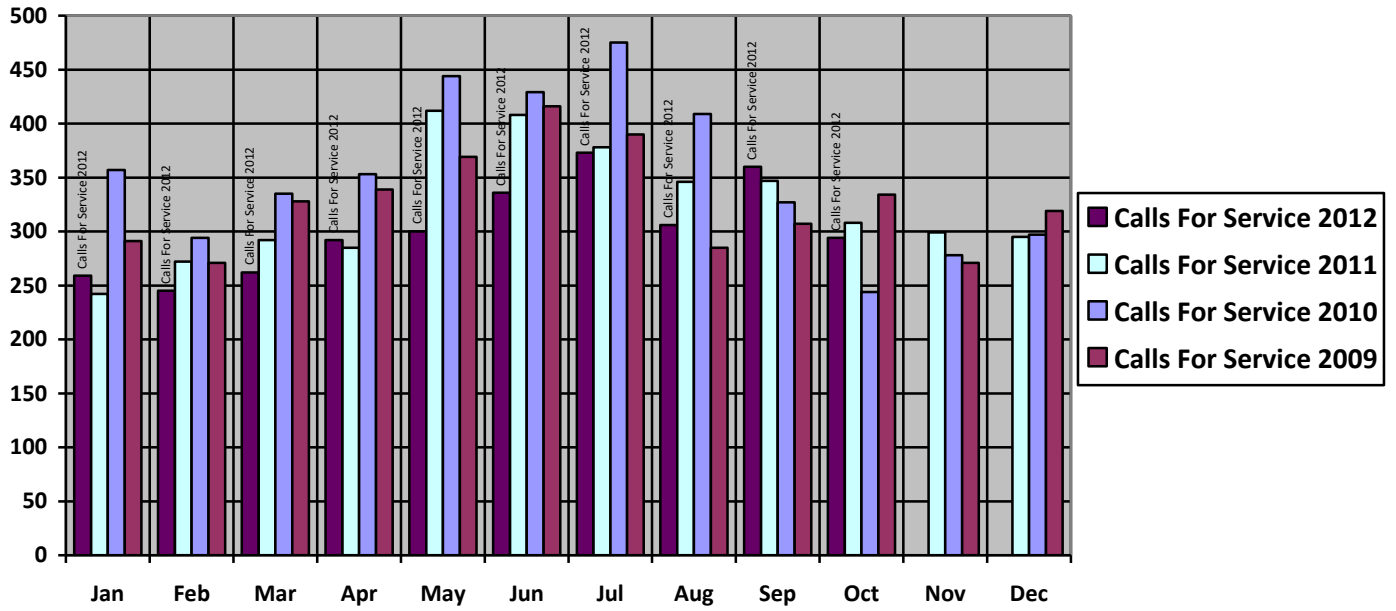
