

MONTHLY REPORT**October 2011****NEWS:**

1. Ofc. Collins has only one more day of classes left for her "law package" certification process. She will begin to put more time in with Field Training in hopes of getting her on her own before the end of the year.
2. 9th Annual Trick-or-Treating Detail in the Longwoods Park went smoothly again. Capt. Cavanaugh and Cadet Kyle B. were assigned the stationary position at the intersection, Chief Pushee was on his 4-wheeler patrolling the park, and Ofc. Migdal was on patrol in the rest of the town. Although activity was down, we still handed out 100-120 bags to ghosts, ghouls, and princesses!
3. Ofc. Migdal was working during the strongest part of the Halloween Noreaster, and spent relentless hours assisting motorists who were having troubles on the roadways, not getting home until well after 1AM after an 18+/- hour shift.

TRAINING:

1. Planned department training was postponed until November because of scheduling conflicts. We will try to have at least two scheduled November training sessions, and will be hosting members of the Washington Police as guests during these events.

GRANTS:

1. Highway Safety Agency Grants: OPERATION SAFE COMMUTE: This grant program has been started. It will assign one day each month for departments statewide to put extra cruisers on the road for safe driver & enforcement patrols during specific "commuter" hours.
2. Chief Pushee has been approved to start "screening" for Federal/Military surplus under the "1033 Defense Reutilization" Program, and so far has resisted the urge to sign up for some low mileage Military Surplus HumVee's!
3. Due to contacts made at the Public Safety Trade Show in Manchester at the end of September, Ofc. Collins just received a new ballistic vest, at NO COST to the town. This was originally a \$1200 vest. It is new and unused except for fittings, as it was a demonstrator model for a vendor/manufacturer representative.

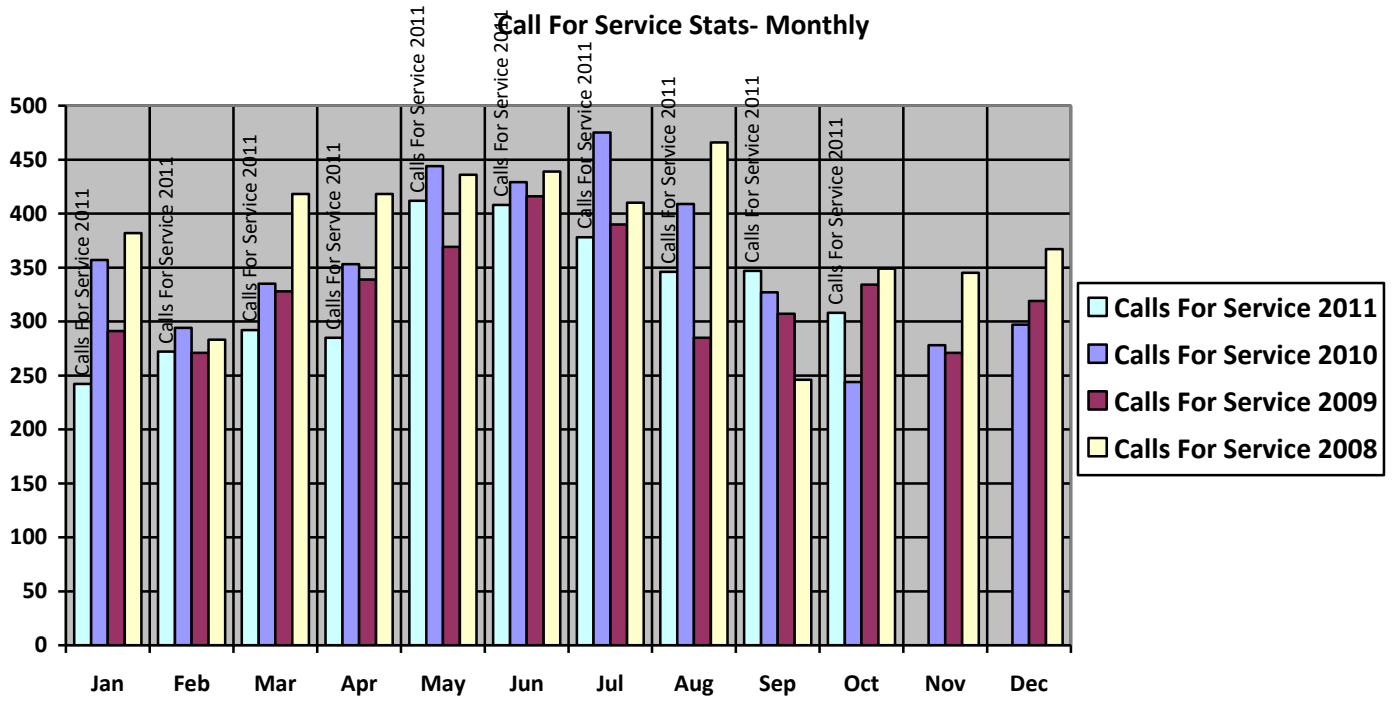
