ARTICLE 2. Shall the Hillsboro-Deering School District set the salaries of the School Board and compensation of any other officers or agents of the District as printed in the 2012-2013 Budget?

District Clerk	\$100 per meeting

ARTICLE 3. Shall the Hillsboro-Deering School District raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth in the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein, totaling \$19,697,182 (nineteen million, six hundred ninety-seven thousand, one hundred eight-two dollars)? Should this article be defeated, the operating budget shall be \$20,227,811 (twenty million two hundred, twenty-seven thousand, eight hundred eleven dollars) which is the same as last year, with certain adjustments required by previous action of the school district or by law; or the School District may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only? (Funds the operating budget for 2012-2013 but does not include appropriations in any other warrant article, except Article #2.)

ARTICLE 4. Shall the Hillsboro-Deering School District raise and appropriate funds from State and Federal aid for the support of school projects as follows: for food service, \$593,500 (five hundred ninety-three thousand, five hundred dollars) and for Federal and State projects, \$900,930 (nine hundred thousand, nine hundred thirty dollars)? These appropriations have offsetting revenues from school lunch sales and State and Federal revenues and do not affect the tax rate.

ARTICLE 5. Shall the voters of the Hillsboro-Deering School District adopt a school administrative unit budget of \$1,012,092 (one million, twelve thousand, ninety-two dollars) for the forthcoming fiscal year in which \$809,346 (eight hundred nine thousand, three hundred forty-six dollars) is assigned to the school budget of this school district? This year's adjusted budget of \$1,027,363 (one million, twenty-seven thousand, three hundred sixty-three dollars) for the forthcoming fiscal year in which \$822,127 (eight hundred twenty-two thousand, one hundred twenty-seven dollars) is assigned to the school budget of this school district, will be adopted if the article does not receive a majority vote of all the school district voters voting in this school administrative unit.
