## **Police Department**

Police Chief Pushee briefed the Board about the department's activities for the month. He explained that the department was now using the NHDoT fuel depot because prices are now lower because of a new fuel contract. Forty-two applications have been received for the new position of part-time administrative assistant approved at town meeting. The Chief had whittled the number of applications down to 19 and is sending them a request for information that will probably result in a further paring down in the number of applicants. Mr. Pushee is looking for the hiring process to conclude within a July time frame.

- 5. Bulletproof Vest Partnership: I have applied online for a funding match to purchase two vests (1 for Capt Cavanaugh, whose vest is more than 8 years old, and 1 for Ofc. Forsley, who was temporarily issued a very used/worn 10+ year old vest until a new one could be purchased).

# JUVENILE ACTIVITY:

- 1. JV Assault Case from March 2018 this is proceeding through the court system.
- 2. JV Runaway Case we located a runaway juvenile who was missing from Hopkington. No local charges nor diversion. Those issues will be handled by home agency (Hopkington).









# April Highway Department's Report

April is here!!! Mother nature has lightened up on us. We had three small storms of three inches or less this month. We used the grader to plow all the gravel roads as they were very soft and used pickup to plow off the pavement. We had to touch up salting and sanding these three storms that we only used a total of 28,950 lbs of salt and a total of 108 yards of sand. The sun is hotter and temps on the rise helps cut our cost of products used this time of year. We held off on opening our town roads up from our spring load limit as they were still very soft until the third week in April. We started working on grading up our gravel roads and adding gravel the last week of April. We were able to install our new kitchen cabinet's, paint the stairs and railings, install eye wash station, first aid kit and a new MSDS station in our shop. We may have finally caught up on repairing our breakdowns. We are working on pressure washing all trucks and equipment to get all the winter residue off them to help with corrosion. It has been a long winter for us with breakdowns and the snow storms and rain we have received this year so far. Lastly, we finally picked up our new dump truck!!! It will be a great addition to our fleet.

#### **NEWS:**

1. Annual hose testing was performed on all hose as per National Fire Protection Association (NFPA) standard 1962, as well as recommended in the MRI Study, recommendation 5. 22. We had a total of 9,990 feet of hose tested and 20% of that hose failed the testing by having holes in the hose, couplings separating with the hose while under pressure. These types of failures are why it is important to have the hose tested annually. If those hoses were used in a fire incident where it is a matter of life or death, it could have ended in a catastrophic manner.

2. Work is continuing on the Forestry to have it ready when the skid unit arrives.

## **TRAINING:**

- 1. Captain Boyll and EMT Brian Rousseau are continuing in an Advanced EMT course, we continue to wish them well.
- 2. Monthly EMS training continues with Hillsboro and Washington EMS personnel. This is a great way to work with neighboring town's EMS personnel.
- 3. I attended a training with Primex called Organizational Change. It was a very informative class and I look forward to attending many more.

## **GRANTS**:

1. With approval from the Board of Selectmen, we will be able to apply for an important grant opportunity. The New Hampshire Department of Safety, Office of the Fire Marshal was awarded a FEMA Fire Prevention and Safety Grant (FP&S). The grant program, Get Alarmed New Hampshire, is a Carbon Monoxide and Smoke Alarm Distribution, Installation, and Education Program. The target audience are owner occupied homes where children 5 years of age and younger and adults 60 and older are residing to provide smoke and carbon monoxide (CO) alarms, installation, and educational materials (free of charge) to New Hampshire homeowners in need. Special consideration will be given to homes where adults age 60 & over and children 5 & younger reside. We have begun to fill out the paperwork and send that out and hope we are excepted for the grant.
