Meeting Minutes September 19, 2018

Selectmen present: Aaron Gill, Allen Belouin, John Shaw.

The meeting was called to order at 1900.

MEETING MINUTES:

Meeting Minutes – September 5th.

Mr. Gill made the motion to approve the September 5th meeting minutes as presented. Mr. Shaw seconded the motion. The vote was unanimous and so moved.

New Business

Police Department

Police Chief Pushee briefed the Board about the department's monthly activities noting that Trish Whisman, the new administrative assistant was doing well acclimating to the position and that a regular schedule of hours was now in place. Public Safety Day is scheduled for October 13th from 1000 to 1300. The Deering Association is trying to arrange the annual cider press for the same day as well. There is an open house schedule for the police cadets on Monday at 7pm. The Board reviewed ordinances relevant to beach parking fines and vehicle towing with Chief Pushee as the Board looks to improve beach parking controls next season.

Fire Dept – Request to withdraw \$10k from Turnout Gear ETF

The Board reviewed a memo from Fire Chief Gorman seeking permission to purchase four (4) new sets of turnout gear from the expendable trust fund (ETF). The TA explained that the Board are named as agents to expend and as such they are the appropriate body necessary to approve the request. Mr. Gill made the motion to approve expending \$10,000 from the Turnout Gear ETF for the purpose of purchasing four (4) new sets of turn out gear for the fire department. Mr. Belouin seconded the motion. The vote was unanimous and so moved.

NH Retirement System 7/1/2019 – 6/30/21 Contribution Rates

The Board reviewed rates for police retirement noting that they will be decreasing by about 1%. They also discussed the possibility of joining the retirement system as a recruitment tool for the highway department (see NHRS rate sheet).

Employee Recognition

Chief Pushee is nominated for McDonalds Night for Community Policing Week 2018 (see attached) and Debra Boyll is chosen as the EMS Provider of the year by the NH Fire & Emergency Medical Services Committee of Merit (see attached). The Board lauded their individual efforts in their respective fields and expressed gratitude that they are part of Team Deering.

AUGUST 2018

NEWS:

- 1. Members of Hillcat Post 612 Cadets helped out with the Hillsboro Living History Event again this year, providing traffic control at the Jones Road reenactment area.
- 2. Members of the Department attended the Town BBQ, the Church Guild Fair, and Ray Petty's farewell reception.
- Members of the Department and the Post 612 Cadets assisted with Patrol and Traffic Control at the Hillsboro Balloon Fest and the Antique Truck Show. 3
- 4. Administrative Assistant Trisha Whisman started her training and is guickly acclimating to the various tasks.

TRAINING:

- Firearms Training The Department did some classroom weapon training, as well as Firearms Range Training. 1.
- 2. The Cadets from Post #612 participated in Firearms Range Training with the Police Dept.
- Both Chief Pushee and Ofc. Forsley attended Transition Training and Certification in the new Intoxilyzer 9000 Breath Test Instruments that will soon be 3 placed in service by the Forensic Laboratory, replacing the very old Intoxilyzer 5000 series machines.

GRANTS:

- 1. 2018 Highway Safety Patrol Grants – These are winding down for the current year in September. Once completed, Chief Pushee will prepare the 4th Quarter reimbursement requests and then the final annual reports.
- 2. 2018 Highway Safety Equipment Grant: We are waiting for copies of the payments on the equipment in order to submit requests for reimbursement of 50% of these costs.
- Bulletproof Vest Partnership: We are awaiting notification on our application for funding of a 50% match for 2 vests under this program. 3.
- 2019 Highway Safety Patrol Grants During July, Chief Pushee attended a meeting with NH-OHS, and was informed that due to new emphasis on data 4. analysis, rather than need and past performance, Deering will receive very little (almost no) funding for patrol grants in the coming year(s).

JUVENILE ACTIVITY:

1. Continuing to have issues with pair of brothers in town. We have begun filing JV Petitions on the older brother in one case, but will be waiting until after his 18th birthday to file additional charges for new offenses that he has been committing recently. Additionally, his 14 year old brother will likely be headed to court relating to recent incidents.







NEWS

We are very excited to say that we are so close to putting Deering Forestry 1 into service. We are just waiting for the person from NH Division of Forest and Land to come out and inspect it. It has been along road with some bumps in the road. The skid unit was damaged when it was delivered from Nebraska. We had to send it back for repairs. It was sent back and it looked much better. We have tested the water pump and it runs great. We hope to have it in service by the end of the week or early next week.

A crew with Engine 2, went to the Deering Community Church Faire on August 11^{th.} We had a great time meeting people and talking to families. Kids were even able to squirt water of a hose and put out a fire in a wooden cutout of a house on fire.

The drinking water at Donovan Station tested due to the NH Department of Environmental Services recommendation to all NH rural fire departments that get their drinking water from a well, tested. We are happy to say it came back perfectly clean.

As you know, in a small town it is always difficult to find volunteers. The volunteer fire service is no exception. It is a constant balancing act to try to have enough personnel to safely handle the many different types of calls we need to be prepared to do, and not have too many members that can be costly to equip with fire gear, boots, helmets, gloves, pagers and several other pieces of equipment they will need. We are in the process of talking with some personnel that are currently not responding to many calls to determine why they are not responding. As you well know, it is really tough today to balance work, family, friends and other commitments, and find time to make a commitment to something else on top of that. It takes a special person to make that commitment. For that reason, we continue to except applications for new recruits.

We currently have several applications on my desk. The standing committee made up of the Assistant Chief, two Captains and a Lieutenant, will meet with each one for an interview. If the standing committee recommends it, the applicant will have a Fire Chiefs interview to discuss expectations, rules and regulations. If approved, I will make the recommendation to the Board of Selectmen. From there, the recruit will go through a probationary period, learning the rules and regulations, apparatus equipment inventory, and the learning continues from there.

TRAINING:

- 1. There was monthly EMS training with Hillsboro EMS personnel.
- 2. Fire training featured pumping fire trucks using multiple sized hose lines. This is a little more difficult for a pump operator as they have to manage the different pressures without losing or diminishing water flow to any of the hose lines.

GRANTS:

1. Assistant Chief/Fire Warden is currently working on the grant through the NH Division of Forest and Lands in order to purchase more tools and equipment for the Forestry. This grant will save us approximately \$1,000.00 next year.

Upcoming goals:

- 1. SCBA mask fit testing of all fire personnel.
- 2. Continue to work on the 2019 operating budget.
- 3. Continue the process of revising our current Standard Operating Guidelines.

We would get the road open for travel then in the next day or so go around and clean up the mess on the road sides. We are getting a decent sized brush pile in our pit. With fall just around the corner, our next projects will be screening our winter sand, getting some more of our catch basins cleaned out and culvert/driveway repairs at the Donovan Fire Station. July was a tough month being shorthanded with two men in and out dealing with Lyme. We look forward to August being a much healthier one.
