She also said the other 3 properties up for deeding are believed to be abandoned mobile homes and she doesn't recommend deeding Them. She asked the Selectmen to allow TA Flynn to contact the park owner to ask if together they could come up with something to do with them. It was agreed to attempt to contact and work with the park owner and contact Legal Counsel if it does not produce any results.
