



Deering Conservation Commission 2013 Wood Duck Box Report

The Deering Conservation Commission (DCC) maintains dozens of nesting boxes throughout the town, primarily on its many conserved lands. The boxes were installed with the intention of providing suitable nesting opportunities for Wood Ducks. Annually, DCC members fan out across town to locate the boxes, see if they've been used, record the results, and refresh them for use during the coming nesting season.

PROGRAM UPDATES:

Nearly all of the active boxes now have GPS markers and are visible on the Commission's Google map, included in this report. Using the GPS maps helps DCC members find boxes and see where ducks are supported throughout town—it's really cool too. The DCC portion of the website has also been revamped to include annual duck reports from many past years, and the GPS Google map.

During the fall of 2013, the DCC built six new boxes and repaired four older ones. As of this report, six have been installed: Two at Tree Frog Pond (Audobon), one at Pattern Marsh, one at Pleasant Pond Road, and two at Poling's Marsh. One more is on its way to Clifton's Camp, and the remaining three are earmarked for a summer installation at Central Rangeway Pond.

Speaking of Central Rangeway; this formerly abandoned location was revisited this winter, and the DCC has committed to supporting it once again. Bordering the Tom Rush Forest (SPNHF), it's a bit of a hike, yes, but the pond is about the same size as Hunter's Pond and is remarkably remote, making it a perfect spot for duck nesting; at least it should be.

Clifton's Camp is coming back online as well thanks to supportive landowners, and Wilkin's Cemetery will also welcome its one duck box back this spring.

Poling's Marsh received a second box, as the site is large enough to support it with one proper dam generated pond, and a smaller beaver dam pond upstream. Pleasant Pond Road had a failing box which was notably far away from water—the box was replaced and moved near the beaver dam pond. Pattern Marsh received a new box on the beaver dam pond, though its existing pole-mounted box was lost. The DCC is considering replacing next year on a nearby tree instead.

At the Lead Mine ponds, an old box was discovered this year on the lower pond, while a newly replaced box from last year was lost on the upper pond. That one bugged me, as it was a new box in an active spot. Tree Frog Pond (Audubon) received two new boxes placed on live trees on the 'shoreline,' replacing two legacy boxes that were likely 20 years old.

There remain some locations throughout town that likely have boxes that have yet to be found, though these locations typically have only one, perhaps two boxes, and are not used at a high enough frequency to make them a priority. These are labeled as either unchecked or abandoned on the success rankings chart.

In particular:

Mud Pond: Abandoned March 2013-the location is active, but a death trap

Homestead Marsh: Abandoned March 2014-Simply put, I can't find it Lead Mind, high/upper pond: Abandoned March 2013-beaver dam burst, no water

Dudley Pond Beaver Dam: Abandoned March 2014-beaver dam burst, no water/poor history

SUMMARY OF RESULTS:

During the 2013 cleanout season, the DCC checked all of the boxes on their active roster. Many boxes have been replaced and moved over the past two years. Ducks aren't immediately trusting of this, and it shows in the box usage results – just 21.6%, down from 32.5% the prior year and well under the 31.9% average. Some of this may also have to do with the trend of moving boxes off the water and onto the shoreline. The on-the-water boxes are favored by mergansers, while the shoreline boxes in the trees are favored by the wood ducks. We'd rather our wood duck

boxes were used by wood ducks, though it may be a few years before the woodies start using these new boxes.

No dump nests this year, and only one flying squirrel box.

LOOKING AHEAD:

I don't believe a new batch of boxes is necessary for next year, though with the older boxes I took down, I should be able to cobble a few together incase they're needed during the 2014 cleanout season.

I located a sizeable pond on my way to the Pleasant Pond Road boxes, located on the Burke conservation easement. I'm looking into access to see if the DCC can utilize the sight for duck boxes. If so, we may add three to that location, in which case I'll need to build a few!

CONCLUSION:

While the ducks didn't bite as much this past year, we did clean out all the boxes on the roster. As we did build and install several new boxes in new locations, there are more useable ones in service. Several members were overjoyed to use GPS to find boxes at locations they'd never been – they could walk right up to the box now!
