

**MONTHLY REPORT****February 2010****NEWS:**

1. Completed the Selection Process for open PT Office Position. Chief Pushee and Capt. Cavanaugh are now starting on the background investigation of our chosen candidate.
2. Ofc. Hargreaves is beginning to take control of the Explorer Post. He and I have recruited several new members, and the Post is now meeting almost every week. We are beginning plans for the Annual Competition at the end of April, and will once again be sponsoring the Building Search Scenario portion of that statewide event.
3. Chief Pushee has been selected by the NH Chief's of Police Association to serve as the "Small Town PD" Advisor on the Local Government Center's "Model Policy" Committee.

**TRAINING:**

3. Police Department and Cadet Post trained/recertified in Basic First Aid.
4. Chief Pushee assisted at the Police Academy by instructing MEB Advanced Police Baton Class to Full Time Police Recruits.
5. Officer Censabella attended a Firearms Refresher class at Police Academy
6. Capt. Cavanaugh re-certified as Breath Test Operator.

**GRANTS:**

1. Speed Enforcement Grant 2010 / Highway Safety Grant Programs: This grant proposal was approved in January, and we began working these "extra duty" directed enforcement patrols in the beginning of February 2010.
2. DWI Enforcement Grant 2010 / Highway Safety Grant Programs: This grant proposal was approved in February, and we will begin working these "extra duty" directed enforcement patrols in the beginning of March 2010.
3. Statewide DWI Hunter Program: NH Highway Safety has requested we sign on again for the three weekends of Statewide DWI Enforcement Grant Programs. We will be receiving formal applications soon.
