

MONTHLY REPORT**August 1st to 31st, 2015****NEWS:**

1. 2014 Cruiser is finally back in service. Waiting for final bills/invoices from emergency equipment vendor and graphic vendor.
2. Ofc. Bell is up and running his own shifts now.
3. Ofc. Parsons has finally been cleared by his Physical Therapist to return to duty mid-September, following a knee injury last winter.
4. Chief Pushee and Advisors Hargreaves and DeOrio took a group of our Hillcat Police Cadets on a Summer "Super Tour" to Washington DC for four days!
5. Members of the Hillcat Police Cadets provided over 50 man hours of Community Service helping out at the Living History event in Hillsboro.
6. Speeding Traffic Complaint on Camp Road: we conducted 4 Traffic Surveys on this road (4 hours of Radar). During that time we saw 4 vehicles in total, and all four were WELL below the posted 30 mph speed limit.
7. General Beach/Boat Launch Area Concerns: On 15-20 different occasions we spent 10-30 minutes of time specific to this area. We found very few violations of parking (3 warnings issued), and did not find any active alcohol violations.

TRAINING:

1. The Department conducted practical Dim Light/No Light firearms training this month at our range on Hedgehog Mountain Road.
2. The Department conducted classroom, policy, and practical training in the use of our new Stop Stick tire deflation devices, and these are now deployed in our two cruisers.

GRANTS:

1. Highway Safety Agency Grants:
 - a. OPERATION SAFE COMMUTE 2014-2015: We continue working these patrols once a month.
 - b. SPEED ENFORCEMENT: We have begun working these patrols, and Chief Pushee submitted quarterly reports and reimbursement requests
 - c. DWI ENFORCEMENT: We have begun working these patrols, and Chief Pushee submitted quarterly reports and reimbursement requests
 - d. TRAFFIC SIGN/SIGNALS: We have begun working these patrols, and Chief Pushee submitted quarterly reports and reimbursement requests
2. TIRE DEFLATION DEVICES: Chief Pushee has submitted for reimbursement for this grant.
3. FY2016 Highway Safety Grant: Chief Pushee is working on preparing the new Application form for the "STEP" grants (combines our previous Speed, Safe Commute, and Stop Sign patrol grants) and the "DWI Hunter" grants. These are due by September 15th, and if approved will begin on January 1st.

JUVENILE ACTIVITY:

1. We have no Juvenile Diversion Referrals or Court Actions in August 2015, but we do have a JV Case pending the completion of an investigation and determination on how best to address the issues.

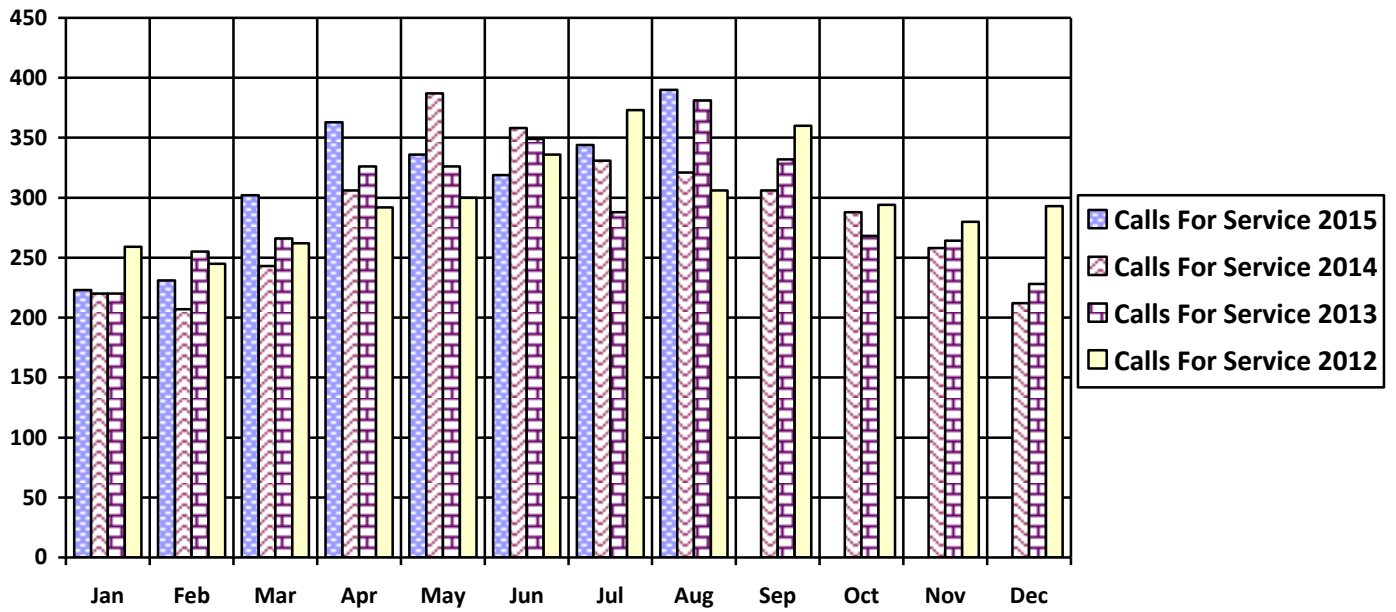
