NEWS:

- New Recruit Officer (Part Time) Joe Rackett was sworn in. He has started some in-house training, and is scheduled to go to Part Time Police Academy in 1. February.
- 2. Chief Pushee attempted to use up some leftover vacation time, but due to family emergencies & training schedules with other officers, still has 16 hours leftover from 2013.
- Ofc. Parsons was out of service in training and vacation for more than 3 weeks, Capt. Cavanaugh was out on family leave for more than 2 weeks, and 3. Chief Pushee was out on vacation/holiday for more than a week. DPD Officer's covered most of the lost time "on-call" though State Police also covered some on-call time.

TRAINING:

- 1. Ofc. Parsons attended a 2-week Traffic Crash Reconstruction Class in Connecticutt. He is now a certified Crash Reconstructionist.
- 2. Ofc. Bennett went to the Police Academy and passed his pre-academy Physical Agility Testing requirements.

GRANTS:

- 1. Highway Safety Agency Grants:
 - a. OPERATION SAFE COMMUTE: We continue to work this grant one (specified) day each month This will compliment the morning and afternoon commute times with an extra officer dedicated to MV Safety Enforcement Patrols for one specified day each month.
 - SPEED Patrol Grant: The application has been sent in, but we are waiting for release of federal monies. b.
 - DWI Patrol Grant: The application has been sent in, but we are waiting for release of federal monies. C.
 - CRUISER VIDEO GRANT: this application has been sent in to Highway Safety and Chief Pushee is awaiting its return for town approval. The d. review and hopeful approval is awaiting the release of federal monies to the NH Highway Safety Agency.

JUVENILE ACTIVITY:

We had NO Juvenile Diversion cases this month. BUT we have filed a Juvenile Petition in Court against a 17 (then 16 year old) student who has repeated 1. caused breaches of the peace at the Alternative School, including one incident where he climbed on the roof of the building.


