

**MONTHLY REPORT****February 1<sup>st</sup> to February 26<sup>th</sup>, 2015****NEWS:**

1. Ofc. Vaillancourt only has a couple more classes at the Academy for his Law Package certification.

**TRAINING:**

1. Officer Vaillancourt is taking his "Law Package" classes at the Academy.
2. ALL Officers attended Annual TASER and OC Pepper Spray Recertification Classes held jointly with Hillsboro PD
3. ALL Officers attended our Annual required 4 hour "Use-of-Force" Classroom Training session here at Town Hall.
4. Chief Pushee was ReCertified as an Instructor for OC Pepper Spray and assisted for two days with teaching the Recruits of the 166<sup>th</sup> NH Police Academy with their Basic OC Pepper Spray class.

**GRANTS:**

1. Highway Safety Agency Grants:
  - a. OPERATION SAFE COMMUTE 2014-2015: We are working this grant one day each month, as assigned by the NH Highway Safety Agency. This grant provides an officer specifically for traffic safety enforcement efforts during the commuter hours.
  - b. SPEED ENFORCEMENT: We have begun working these patrols.
  - c. DWI ENFORCEMENT: We have begun working these patrols.
  - d. TRAFFIC SIGN/SIGNALS: We have begun working these patrols.

**JUVENILE ACTIVITY:**

1. We have no Juvenile Diversion Referrals or Court Actions in February 2015.
2. We did have an assault incident at the Alternative School, but this will be handled administratively by the School and the Juvenile Probation Officer involved.

	Conduct After Accident	(warrants are being prepared)

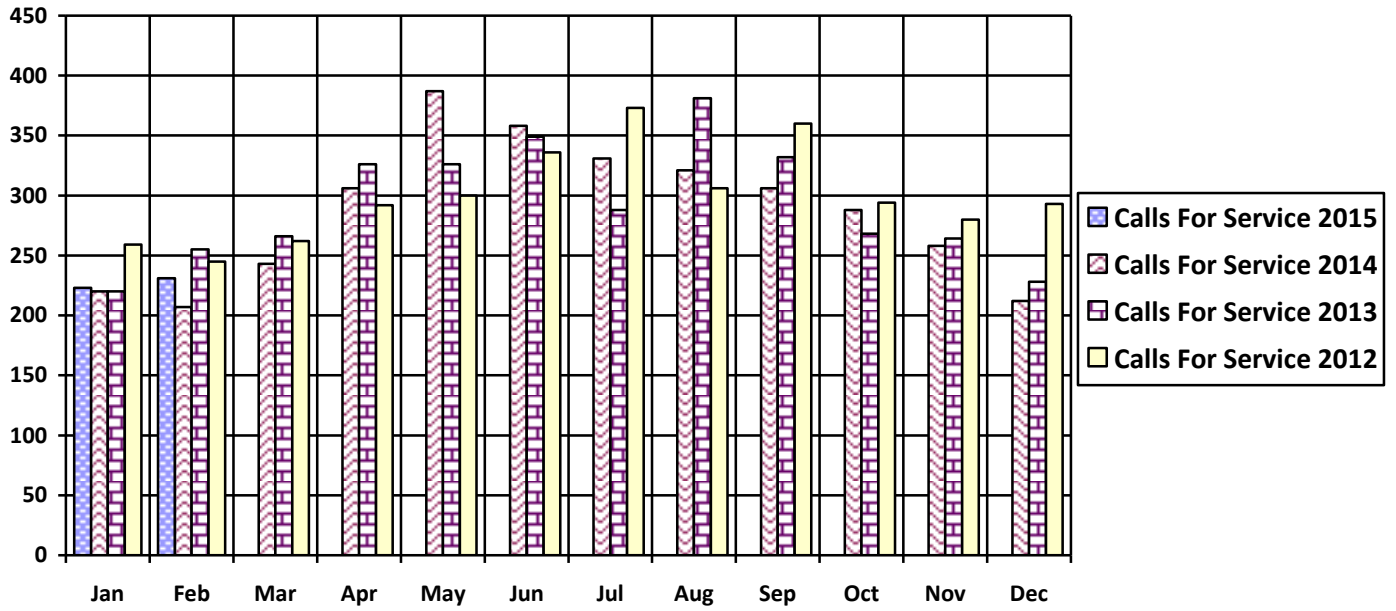
**MILEAGE TOTAL:**
