1. Internships: We continue to sponsor HS Student Ryan L., but upon a plea/request, we also added a second High School Intern, Bryson P.

GRANTS:

1. Highway Safety Agency Grants:
 - a. OPERATION SAFE COMMUTE: This grant program has started for 2012-2013 season. It will entail two 3 hour shifts during commute time on one specific day each month, in conjunction with most other departments statewide. **GRANT WAS APPROVED.**

 - c. DWI Patrol Grant: Chief Pushee will be looking to begin the application process for the next series of this grant soon. **IN PROCESS**

3. Portable Radio Grant #2 – Chief Pushee has completed the necessary forms and application to receive, sometime this spring, a second portable radio on this grant program (\$3,800 value).

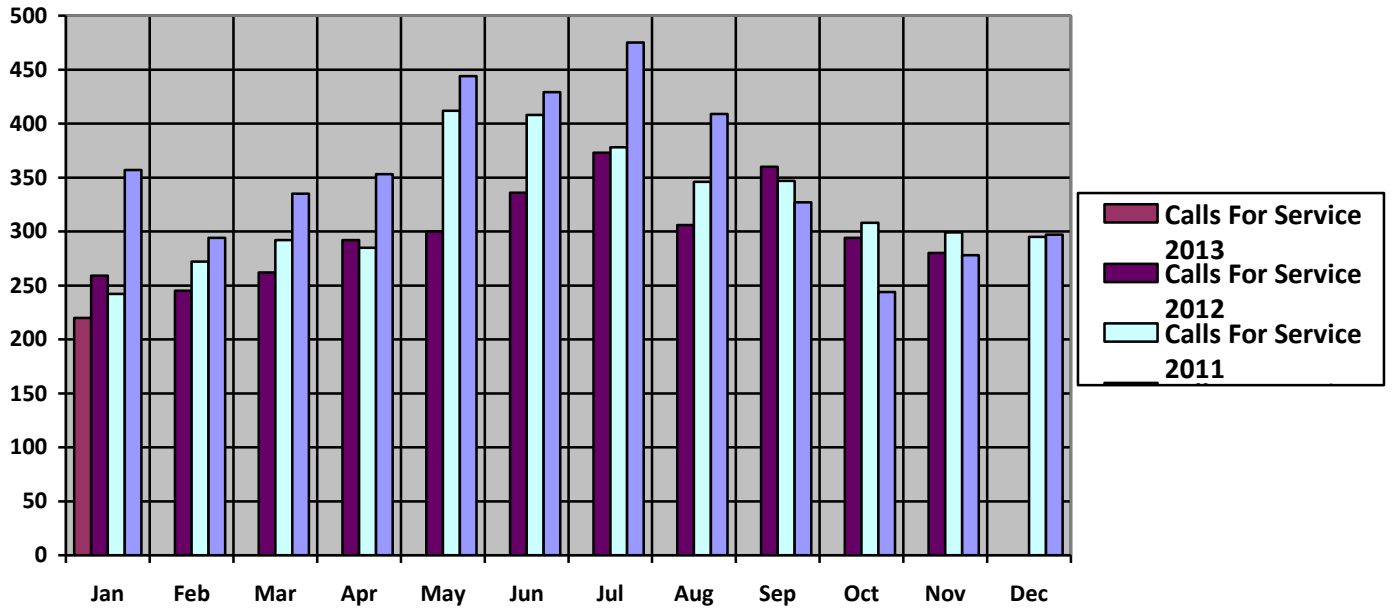
