

**MONTHLY REPORT****May 1<sup>st</sup> to May 31<sup>st</sup>, 2015****NEWS:**

1. 2013 Cruiser had a wheel bearing replaced under warranty. It is also back at Grappone to "re-fix" the door panel skins.

**TRAINING:**

**GRANTS:**

1. Highway Safety Agency Grants:
  - a. OPERATION SAFE COMMUTE 2014-2015: We continue working these patrols once a month.
  - b. SPEED ENFORCEMENT: We have begun working these patrols, and Chief Pushee submitted quarterly reports and reimbursement requests
  - c. DWI ENFORCEMENT: We have begun working these patrols, and Chief Pushee submitted quarterly reports and reimbursement requests
  - d. TRAFFIC SIGN/SIGNALS: We have begun working these patrols, and Chief Pushee submitted quarterly reports and reimbursement requests
2. TIRE DEFLATION DEVICES: We have received final approvals for this grant program, and can now move forward with authorization to purchase.
3. Speed Enforcement Equipment: There is currently (or was as of Friday May 22<sup>nd</sup>) an opportunity to save thousands of dollars on a new LIDAR unit through MPH Industries. I inquired about the opportunity to submit an Equipment Grant through NH Highway Safety Agency, but after consideration, they have denied this because equipment grant applications were due prior to April this year.

1. We have no Juvenile Diversion Referrals or Court Actions in May 2015.
2. We have filed a Juvenile Petitions to charge a young female with Possession of Drugs from an April 2015 case.

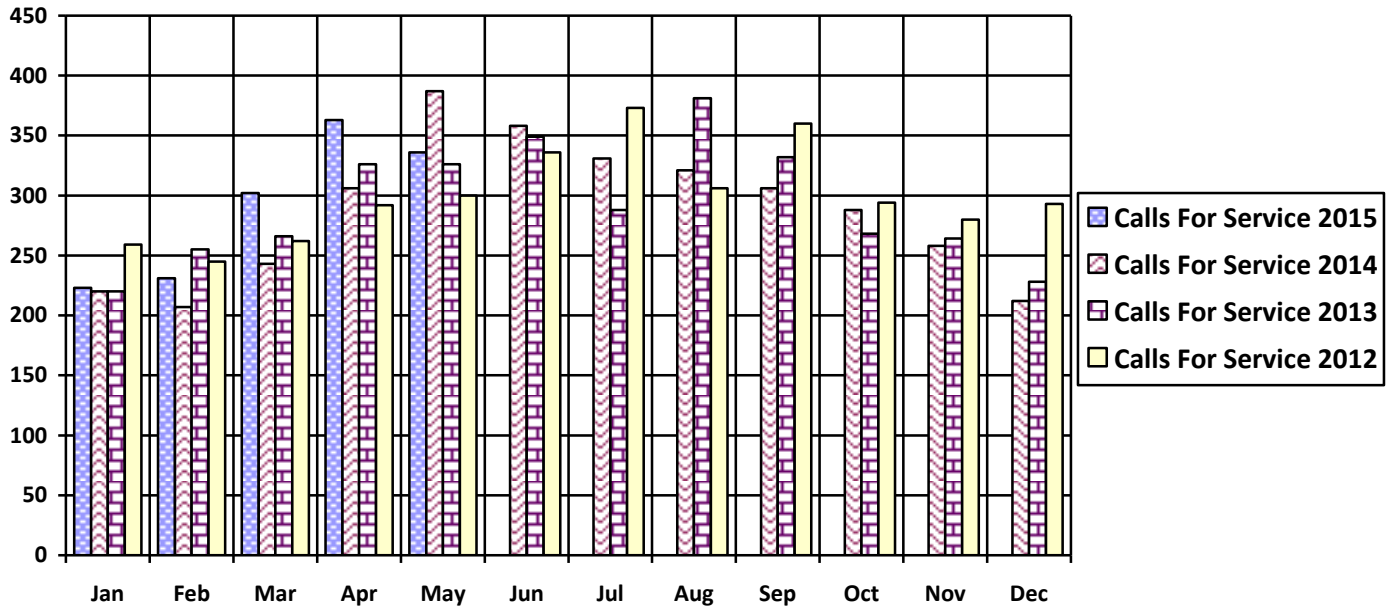
