 - 2. There are plenty of people who are not working remotely, and cannot work remotely.
 - a. This isn't what teachers were hired to do. They were hired to educate the children in person.

iii. Plater

1. Would like to see the numbers stay consistent for two weeks before the students go back to in person learning.

iv. Pelletier

- 1. Has no problem with bringing the students back on the 19th
- 2. Feels more concern for the staff.
 - a. If he were a teacher, he would be concerned about going back.
- 3. It is time to go back to in person learning.

D. Discussion Items

a. FY22 Hillsboro-Deering School District Budget and Warrant Articles

- i. Pelletier
 - 1. It's kind of disappointing that we got very little feedback
 - 2. Doesn't think this format works.
 - 3. The Default Budget
 - a. Agrees with John Segedy that if we are cutting staff positions, they should come out of the default budget
 - 4. The estimated revenues slide in the presentation

- a. Knew things were bad, but this is horrible
- b. This equates to over an 8% increase in local taxes
- c. Understands that we need a good school system, but we are pricing ourselves out of business.
- 5. Knows that the administration has done a wonderful job on this budget, but based on the coming tax increase feels we should be doing more with this budget to offset this.

ii. McGinn

- 1. A 1.8% increase in the budget is low for the district.
- 2. There is so much in this budget that we have no control over.
 - a. How much do we cut?

iii. Bober

1. There is not much more we can do to decrease the budget at this point.

iv. Mary Henry

- 1. The Disparity Aid money that the state gave the districts last year was used to offset the tax rate, and we don't have that this year.
- 2. The budget used in the comparison for last year vs this year does not include the warrant articles.

- i. When talking about the warrant articles, we should have the current balance of the Trusts in the presentations.
- ii. The Warrant articles 6-10 should say the sum of "up to"
 - 1. Will also check the wording on the rest of them
- iii. The presentation packet includes the warrant article for retaining up to 5% of the net assessment for a contingency fund.
- iv. McGinn sent a synopsis of the Deliberative Session plan to the Board
- v. Segedy
 - 1. We would like to do the Deliberative Session in Person
 - a. We have to do it in person This is the consensus from the attorneys and others at the session.
 - b. The only other option is to postpone the Deliberative Session
 - c. Would have to postpone the Deliberative Session every 3 days
 - 2. The ventilation at the Middle school is better than at the high school.
 - 3. Suggests having separate rooms for people who do not wear masks and one for those

- a. The consensus with the attorneys is that you cannot stop people from participating. One room should be reserved for people who do not want to comply with the mask mandate.
- 4. Has three possible assistant moderators
 - a. Does not have one who would be able to be in the room with the non-compliant people.
- 5. Asks the Board to put up plexiglass for the moderators
- 6. Would also like an extra rack of chairs to be available for people who come as a "pod" so they can sit together
- 7. We need to make sure that we are ADA compliant, people need to be able to see and hear the Board.

vi. McGinn

1. The Board will vote on the Deliberative Session Plan tonight and we will work on the logistics at a later date.
