 - a. No, each of the people who manage a grant are here and work for us. They will have a better understanding of what needs to be done.

G. Presentation

- 1. H-D Elementary School CSI Update Donna Furlong, Jeni Laliberte
 - a. Enrollment Trend
 - 1. Enrollment is down much lower than usual due to Covid.
 - 2. The Free & Reduced Lunch enrollment is also much lower due to people not filling out the forms this year.

b.Percent of Students who are proficient

- 1. Our trends are not great a number of students are not meeting the state average for proficiency.
- 2. We are currently in the Winter assessment session, and do not have those numbers to share with the Board tonight.

c. What we are proud of

- 1. Change in the administrative model of the elementary school from a typical Principal and Assistant Principal to a Lower Elementary Principal and Upper Elementary Principal.
- 2. Additional Staff
 - a. Behavior Interventionist and additional school counselor.
- 3. Extensive work has been done with WestEd to create Professional Learning Communities and follow protocols for unpacking standards and lessons.
- 4. Teachers and staff are open and willing to look at instructional practices and grow their professional teaching practices
- 5. Continued work with aligning curriculum and assessments to standards.
- 6. Adoption of a new mathematics program, Ready Classroom, and ELA program, the Lucy Calkins Units of Study in Reading.
- 7. District wide adoption of iReady diagnostic assessment system. We have also purchased the Instructional package in mathematics. The program creates a student-specific "path" and focuses on student weaknesses.
- 8. Flexibility from staff adapting to remote learning, as well as hybrid teaching.
- 9. Creating an MTSS-B team of educators to implement a school-wide behavior intervention system.

d.Priority Goals

- 1. By June 2021 HDES Administrators will make performance expectations clear to staff and improve structures and opportunities for teachers to receive training, coaching and feedback by effectively implementing the current evaluation plan.
- 2. By June 2021 HDES will increase alignment of curriculum, instruction, and assessment to standards to improve consistency of instructional rigor and academic expectations within and across classrooms and allow for teachers and support staff to develop expertise with innovative and engaging instructional practices across the curriculum by implementing a Professional Learning Community.

3. By June 2021 HDES will increase behavior support systems, practices, and instruction at the classroom and school wide levels, that encourage a focus on learning and self-regulation, address student social-emotional needs, and decrease classroom and school community disruptions by developing consistent social-emotional support structure and a system to monitor student behaviors and interventions.

- 6. curriculum work to support engaging academics

 - a. Responsive Classroom

- 1. Plater
 - a. Concerning Math, is one of the problems the numbers themselves, or the verbiage of the problems? Is it both, or are we behind in the numerical problems?
 - i. Furlong Believes it is a little bit of both. The method of teaching math has changed over the years. It's not simply addition, subtraction, multiplication, and division anymore.

2. Iadonisi

a. Is glad to hear that students are getting a solid foundation in math at such a young age.

3. Bober

- a. Priorities and Goals When you identified your 3 goals, what was your process in identifying those goals?
 - i. A lot of the process came from the call surveys.
 - ii. We have also worked with WestEd.

H. Public Comment

1. Jon Daley

- a. The slide with the priority goals that is what the people were asking for on Saturday.
- b. Wanted to talk about the contingency fund article -
 - 1. It was stated at the deliberative session that it was 5% of the school budget, but has also heard that it's 5% of the net assessment of the district would like clarification on this.
- c. Wants to point out that this is not just like the Town's contingency fund.
- d. Please clarify the budget line items "salaries"
 - 1. Do these include salaries and benefits, or just salaries?

I. School Board Response to Public Comment

- 1. Pelletier
 - a. The new Fund the public will be voting for in March. Would like clarification that the 5% assessed value is based off of.
 - 1. No matter what the number is, the Board will not take the 5% and take it all at once. This would be a gradual process
 - 2. To spend the money, we would have to have a public hearing in addition to the approval of someone in the DOE.

2. Mary Henry

- a. The 5% is on the net value of the town.
- b. This fund is like the Town's fund. The town can use the money for warrant articles, and then have it voted on. The town can also use this to offset the tax rate.
- c. This fund serves the same purpose as the town's fund.
- d. Clarification on Rich's statement The Board no longer has to add

3. Bober

a.Can we get clarification on how this assessment is split between the two towns?

J. Superintendent's Report

- 1. General Update
 - a. \$4,629.18 anonymous donation from a Deering resident to go towards paying off the Hillsboro-Deering student's school meal debt.
 - b. Hillsboro-Deering will be receiving around \$1,398,929 from the Federal School aid package coming up. Patty will report back to the Board with more information when it comes in.
- 2. Decision Matrix Update
 - a. See attached sheets
- 3. Re-Entry Plan Reassessment
 - a. Pre-School Danielle Parenteau
 - i. Preschool programming is staffed by two special educators/classroom teachers
 - ii. September
 - 1. Seven students with specialized instruction and related services in the building, one remote.
 - 2. preschool day consisted of three sessions
 - 3. Students received 1:1 instruction.

iii. October

- 1. Fourteen students registered to be screened by preschool staff and related service providers.
- 2. allowed for preschool team to gather baseline information
- 3. twenty-two families requested access to remote preschool programming
- 4. preschool staff upload activities and communicate with families using canvas

iv. November

- 1. The preschool program expanded by adding new students
- 2. The preschool program remained in the same model.

v. December

1. Preschool continued

vi. January

- 1. the preschool program expanded to include typical students
- 2. eleven new students enrolled in the preschool program
- 3. six new preschool aged students

vii. February 2021

- 1. Three preschool programs, two morning sessions and one afternoon program
- 2. morning sessions run two days a week
- 3. afternoon session runs four days a week
- 4. Twenty-two students receive preschool programming.

viii. Future plans

1. The preschool staff and administration will continue to evaluate the preschool program in order to assess if more students can be enrolled.

b. HDES – Donna Furlong

- i. The Goal: Bring 3rd-5th grade back in 4 days per week while maintaining a minimum of 3-6' distancing.
 - 1. K-2 is fully back in school. 3-5 are still in the hybrid model.
 - 2. Wednesdays are full remote days for everyone.

ii. Things to consider

1. Eating

- a. Lunches will be held in the cafeteria at desks 6' apart (teacher choice)
- b. Snack will be ½ in classroom and ½ in cafeteria socially distanced (teacher choice)

2. Recess

a. continue to have four zones, students will wear masks if within 6' of others

3. Classroom

a. Masks will be worn if less than 6' distance can be maintained.

iii. Proposed changes at 4th grade

1. Barrier: large class sizes, small rooms, high student needs requiring many adults.

- 2. Solution: add a fifth 4th grade teacher
 - a. reduces class sizes to approximately 14 per class, so able to accommodate closer to 6' distancing
 - b. smaller class sizes mean more direct support from the teacher

3. However...

- a. Some students will be pulled from the classroom they have been in all year and start with a new teacher
- b. Students who are hybrid who have returned from remote model will also have to change classes.

iv. Proposed changes at 5th grade

- 1. Students will be closer to 3-4' distancing (3'desk to desk, 4' head to head)
- 2. all countertops, bookshelves, tables, cabinets will be removed.
- 3. 6' buffer in front of room for teacher and students
- 4. students who are hybrid who have returned from a remote model will have to change classroom teachers.
- 5. Flexibility will be the key! Decisions about the number of in-person, hybrid and full remote classrooms may vary depending on numbers!

v. Other things to consider

- 1. Teachers would only be teaching one format: either Zoom OR in-person
- 2. If a student has to be out for any reason, they would not be able to connect remotely.
- 3. More students have the option to return on 3/22
- 4. Warmer weather will allow us to be outside more.

vi. Timeline

- 1. 3rd grade: Monday, February 8th
- 2. 4th Grade: Monday, February 17th
- 3. 5th Grade: Monday 5th
- 4. Model will be reassessed for more students potentially returning March 22nd.

vii. Ouestions

1. Iadonisi

- a. Has there been any consideration for plexiglass barriers?
 - i. This isn't a consideration that was brought up when talking to teachers.
 - ii. There are a few barriers that are being used by teachers who are working one-on-one with students.
 - iii. There are other schools that are using them, so we can definitely have a conversation about having these.

- b. Bussing how will bussing work with bringing the extra
 - i. Right now, students are seated in every other seat.
 - ii. We would need to have families sit together with the increased number of students.
 - iii. We will need to get a better idea of the numbers
- c. Where would the new teacher be based?
 - i. They would be based in the 4th grade wing
 - 1. Another teacher would be displaced, but we have options for them as well.
- d. Where would we get the salary and benefits for this position?
 - i. This can come out of the CARES Act funding.
- e. If a child has a sniffle, and can't go to school, but they also can't access the class remotely - feels this would not work. Could the student not be absent and join the remote teacher's classroom?
 - i. There are several factors that would affect this, but we are looking at the options.

2. Pelletier

- a. You're asking us to add an additional teacher for the 4th grade, which would allow for smaller classes but saying that a student who has to be out, can't remote in?
- b. Feels that a student who has to be out, they should be able to remote into their classroom.
 - i. If the teachers are willing to do videos of the day's lessons, wouldn't that be a good compromise?

3. McGinn

- a. What does this do to the students who are already there? Are there any proposed changes to what's going on in the Lower Elementary?
 - i. The teachers would have the option to use the cafeteria space as well.

4. Bober

a. Likes the idea of a compromise using video recording the day's lessons and making them available to the students who are out.

c. HDMS - Marc Peterson

- i. Currently we can have 10 students in the classroom 6' apart.
- ii. We are working on identifying students who would benefit from coming in 4 days a week

- iii. We have been able to honor parent requests to have their students come in 4 days a week.
- iv. One option we are exploring is to have some students in the media center and they can zoom into their classrooms.
- 4. Appointments, Leaves and Resignations

K. Board Discussion

- 1. Deliberative Session Debrief
 - a. Thoughts
 - i. Pelletier
 - 1. a lot of the questions we got are questions that we get every year. People for the most part end up ignoring the SAU budget.
 - 2. Was surprised about some of the outcomes.
 - a. Was pleasantly surprised that there were no efforts to decrease the budget.

ii. Bober

- 1. As we move forward, the Board can make notes to distinguish the SAU budget from the District budget.
- 2. Need to do more to advertise the budget timeline dates in the future.

iii. Plater

- 1. The SAU budget they wanted to see the detailed information.
- 2. Did anyone get a count of the total number of people there?
 - a. The vote at the end was around 50-53, but a lot of people left before the vote.
- 3. We should put sports on the SAU agenda to get the people to attend the meeting.

iv. McGinn

- 1. Feels the location went well
- 2. Feels that the Saturday time worked.
- 3. Did Not like being so far away from the rest of the Board
- 4. Feels the social distancing went well.
- 5. Feels that "We" the Board needs to be more mindful about doing outreach and education on the budget.
- 6. We got a lot of public comment would love to see that much engagement at our regular meetings
- 7. Hopes that everyone who wanted to, were able to speak and get their questions answered.

v. Iadonisi

- 1. Appreciates that the Chair does everything to get the Board's message out there.
 - a. At some stage in the game, we have to hold ourselves accountable. There is only so much the

Board can do to advertise and educate the community.

- b. At the end of the day, people have to want it.
- 2. Support for LSR 887
 - a. What would we like to do?
 - b. Bober
 - i. Feels it would be good for the Board to sign their support to the LSRs
 - 1. Board members can also endorse on an individual basis.
 - c. Pelletier
 - i. Feels we should support both 887 and 1052
 - d. Plater
 - i. Agrees with Rich in supporting both
 - e. McGinn
 - i. We can send correspondence to support both LSRs

M. Public Comment

- 1. John Segedy
 - a. Comments about the Deliberative session
 - 1. Thanks the community for coming out in a tough situation
 - 2. Thankful that we did not need the room for people not wearing masks.
 - 3. We had more people attend than we ever have in the past.
 - a. Feels we should keep the deliberative session on a Saturday
 - i. We can expect to see more participation
 - b. Realizes that the business administrator is new, but there are people on the Board who have been around longer.
 - 1. The information should be on hand and at the ready.
 - 2. Those were not surprising questions.
 - 3. There are reasons people do not go to the SAU meetings
 - a. The people feel they don't get listened to.
 - b. Has personally made comments as a member of the public at the meetings that don't even get discussed.
 - c. Why would anyone bother going if they feel they will not be heard?

2. Brad Chacos

- a. There are a lot of good reasons to bring the kids back to school as much as possible.
- b.It's very important to keep in mind that we are in the deadliest part of the deadliest pandemic.

- c. We need to stick to the medical facts of what will keep our kids and staff safe.
- d.The 3'guidance is political not scientific.
- e. Why rush this right now?
- f. There is a study that has come out that 86% of kids who have had covid, even if they don't have symptoms, have blood vessel damage.
- g.If the Board does decide to put kids in close contact with each other, you need to consider making the class available via zoom while they are doing their mandated quarantines.

3. Heidi Welch

- a. Agrees with Iadonisi about students who are not able to attend in person, they should be able to access the class via Zoom.
- b. The 4th grade teacher being added would only be from February to June as a temporary position? Would like this confirmed.
- c. Has heard that there are 3rd-5th grade students who are back to in person learning 4 days a week.

4. Jon Daley

- a. If it is a public hearing, the voters don't get to vote.
- b. Comments made are often not addressed.
- c. The 5% article Agrees that the 5% would be added gradually, but what about future boards?
 - 1. Boards could put all of the left over money into this fund and the voters have no say.
- d. Feels that 5% of the Town's net assessment would be insane. A potential \$35,000,000 in the fund is ridiculous.
- e. The Board could have written the article to word it differently that would include a number more palatable to the voters.

5. Don Mann

- a. Do we have an IT department?
- b.One thing to think about is having the IT department set up a computer and camera set up with a one password system
 - 1. The teacher could live stream and record at the same time.
 - 2. Would like this looked at.

N. School Board Response to Public Comment

1. McGinn

- a. To John's point about Board response to public comment
 - 1. Feels it's challenging to have the Board to hear the comments, digesting the comments, and responding.
 - 2. We do need to make sure the community knows they are being heard.
 - 3. It's a hard line to balance this out.
- b. The CDC has said that it's safe to have the kids 3-6' apart, and we have to trust the staff to keep our kids safe.
 - 1. This is a hard decision to make.

2. Bober

- a. The retained funds, the reason we put the 5% in the warrant article is that we were told we had to say up to 5% this year, but the Board can change that in following years.
- b. Feels if the staff and administration feels they can bring more students back to campus safely, we should consider this.
- c. We should keep zoom available for students who have to be out for quarantine

3. Pelletier

- a.Do we have to vote on bringing more kids back into the schools tonight? We need more time to think about this.
- b. Is this the right time to bring more students back? Should we give it a week or two to see where the numbers in NH go.
- c. We developed the guidelines for a reason.
- d. How does the staff feel about this? Are they 100% behind this?

4. Plater

- a. Would like to see the hybrid model continue as it is for a while longer.
- b. If we waited a little longer Maybe March 22nd more people will be vaccinated. Feels we will be in a different place and the numbers will be better.

5. Iadonisi

a. The Superintendent prefaced the presentation by saying that the proposal does not necessarily reflect the opinions of the administration.

6. Parenteau

- a. The Board has to make the decision on the Board's risk tolerance.
