2. Started with 3 days of Professional Development and an all SAU #34 meeting
 3. The buildings had 2 ½ days of programming after that
 4. Students came to school on August 31st
 5. Friday, August 26th the outdoor classrooms were ready to be revealed to the staff
- ii. There are a few projects that are not quite completed, but the plan is to have the Board tour the campus at the next Board meeting.
- b. ESSER Update - Grant Geisler
- i. ESSER 1 - Spent all of the \$351,000
 1. Waiting for the last \$24,000 reimbursement
 - ii. ESSER II
 1. Allocated \$1.4 Million - We have spent around \$900,000
 - a. We have been reimbursed a little over \$800,000 so far
 - iii. ESSER III
 1. We were allocated \$3.1 Million - We have spent around \$961,000
 - a. The Outdoor learning space
 - b. The HVAC Projects
 - c. Professional Development trainings
 - iv. Most of the ESSER funds are budgeted for, it all depends on the final expenses for each of the projects.

- i. Our SAU was part of a buying consortium, but we have fallen off their radar
 - ii. We do not have a contract for propane - we are currently paying market rate
 - iii. We bid out for a contract for propane with Rymes Propane and Oil
 - iv. The contract bids offered were
 1. One year - \$1.83/gallon
 2. Two year - \$1.73 8/10 cent/gallon
