**Article #4: To Appropriate Operating Budget Funds for the Year 2024**

To see if the Town will vote to raise and appropriate the sum of **TWO MILLION FOUR HUNDRED THIRTY FIVE THOUSAND TWO HUNDRED SEVENTY DOLLARS (\$2,435,270)** for the purpose of funding general municipal operations not including any amount raised and appropriated in any separate warrant article.

**Two Amendments Passed on Article #4**

**First amendment passed to increase** for a total of **THREE THOUSAND FOUR HUNDRED THIRTY-SIX DOLLARS (\$3,436)** to put \$1,718 back into the Town Clerk Salary line and \$1,718 back into the Tax Collector Salary line which will match the amount that was voted on the approved at the 2023 Town Meeting by the voters of Deering.

**Second amendment passed to decrease** the overall budget by **ELEVEN THOUSAND NINE HUNDRED SIXTY-NINE (\$11,969)** and now raise and appropriate the sum of \$2,426,737

**With both amendments passing** Article #4 now reads:

**Article #4: To Appropriate Operating Budget Funds for the Year 2024**

To see if the Town will vote to raise and appropriate the sum of **TWO MILLION FOUR HUNDRED TWENTY SIX THOUSAND SEVEN HUNDRED THIRTY-SEVEN DOLLARS (\$2,426,737)** for the purpose of funding general municipal operations not including any amount raised and appropriated in any separate warrant article.

**Article #5: To Add Funds to Established Trust Funds**

To see if the Town will vote to raise and appropriate the sum of **THREE HUNDRED FOURTY-NINE THOUSAND SEVEN HUNDRED FOURTY-FIVE DOLLARS (\$349,745)** to be added to the previously established Capital Reserve and/or Expendable Trust Funds and to fund the sum of **ONE HUNDRED THOUSAND DOLLARS (\$100,000)** from the undersigned fund balance as of December 31, 2021
