CEMETERY TRUSTS DISCUSSION – JP READ RSA 289.7 OUTLOUD - ACCORDING TO RSA 289.7  
THE CEMETERY TRUSTEES CANNOT HAVE A CHECKING ACCOUNT. THE TRUSTEES OF THE TRUST  
FUNDS HANDLE ALL PERPETUAL CARE FUNDS.

THERE WAS A QUESTION REGARDING THE INCOME (EARNED INTEREST) FROM THE PERPETUAL  
FUNDS. ACCORDING TO RSA 289.7 THE CEMETERY TRUSTEES MUST PRESENT A  
VOUCHER(REQUEST) THE INCOME FROM THE TRUSTEES OF THE TRUST FUNDS. THE INCOME IS  
NOT AUTOMATICALLY TURNED OVER ANNUALLY.

JOHN REYNOLDS ASKED HOW THIS WORKS. DOES THE TOWN VOTE FOR THE MONEY? WHERE  
DOES IT GO? DISCUSSION FOLLOWED. JP EXPLAINED FUNDS ARE VOTED IN BY THE TOWN  
DURING TOWN MEETING.

JP ASKED WERE THERE ANY PLOTS AND/OR PERPETUAL FUNDS PURCHASED BETWEEN 2019  
AND 2023. JOHN EXPLAINED LAST PLOT SOLD 2021 AND WILL PROVIDE THE COST AND WHERE  
THE MONEY WAS DEPOSITED.

ELIZABETH SUGGESTED ALL CEMETERY TRUSTEES TAKE THE TRAINING OFFERED BY THE STATE.  
IT WAS VERY HELPFUL AND COULD HELP THE CEMETERY TRUSTEES WITH THEIR QUESTIONS.
